KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, default having been made in the payment of the indebtedness due by that promissory note and real estate mortgage securing payment of the same, executed by Mary Ethel Vanderburg to Nora Whatley and recorded in Mortgage Book 381, page 436, in the Probate Records of Shelby County, Alabama, which mortgage described the real estate hereinafter set out and
