Begin at the Southwest corner of Section 17, Township 21 South, Range 2 West, and run northerly along the west side of the said Section 17 for 213.97 feet to a point on the south right-of-way of Shelby County Road No. 87; then turn an angle of 63 deg. 05 min. 16 sec. to the right and run northeasterly along the said south R.O.W. for 855.68 feet; then turn an angle of 42 deg. 20 min. 51 sec. to the right and run southeasterly along the said R.O.W. for 102.65 feet to a point on the west right-of-way of State Highway No. 31; then turn an angle of 38 deg. 43 min. 11 sec. to the right and run southeasterly along the said West right-of-way for 727.73 feet; then turn an angle of 37 deg. 00 min. 59 sec. to the right and run southerly for 59.88 feet to a point on the south side of Section 17; then turn an angle of 24 deg. 46 min. 54 sec. to the right and run southwesterly for 66.76 feet to the point of beginning; then turn an angle of 56 deg. 41 min. 04 sec. to the right and run southwesterly for 350.00 feet; then turn an angle of 32 deg. 30 min. 05 sec. to the right and run northwesterly 157.00 feet; then turn an angle of 126 deg. 55 min 05 sec. to the left and run southeasterly for 111.16 feet; then turn an angle of 84 deg. 55 min. 38 sec. to the left and run northeasterly for 450.83 feet; then turn an angle of 56 deg. 41 min. 04 sec. to the left and run northeasterly for 30.00 feet to the point of beginning TO HAVE AND TO HOLD to the said grantee, his, her or their heirs and assigns forever.
