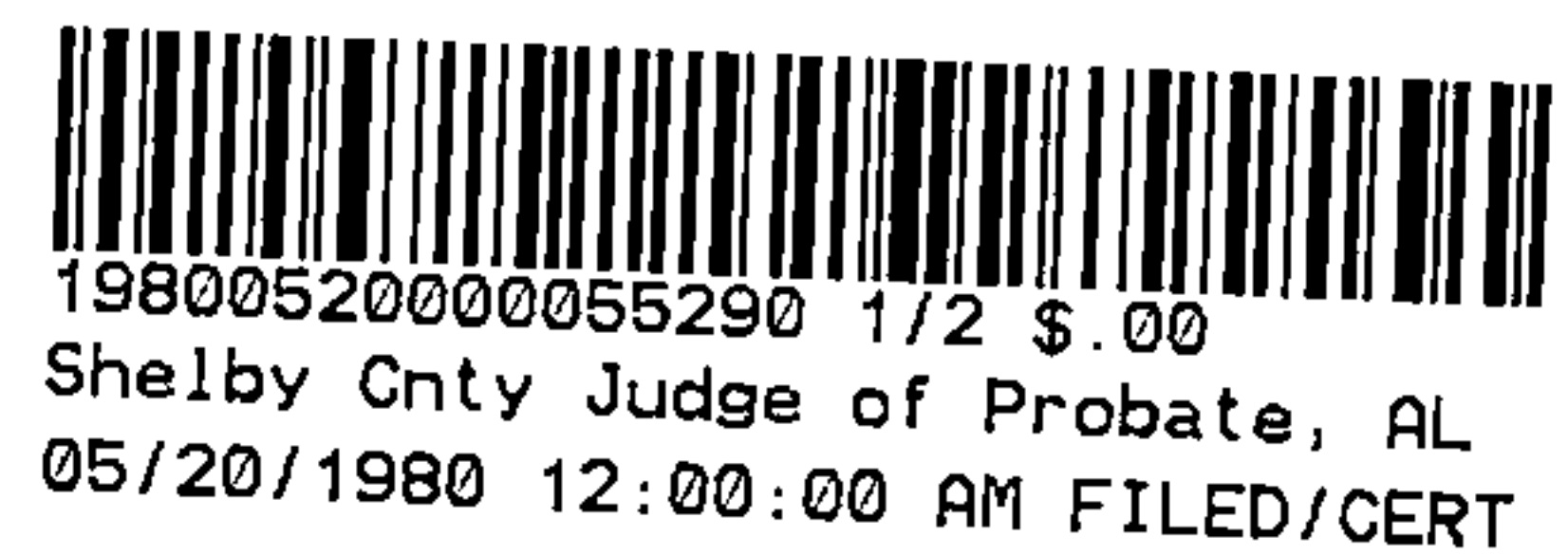

ORDER PASSING FINAL SETTLEMENT  
OF EXECUTRIX



Present, the Honorable Edgar P. Russell, Circuit Judge:

This day being set to hear and pass upon the account heretofore filed by Exie R. Lee, as the Executrix of said estate, for final settlement of her administration thereof; now comes the said Exie R. Lee and moves the Court that said account may be passed and allowed. And it appearing to the Court that due notice of the time and nature of her settlement has been given by publication for three successive weeks in the Marion Times Standard, a newspaper published in this County, and that notice has been given every adult distributee resident in this state; whereupon it is shown and appears that said Executrix has received of the assets of said estate the sum of \$60,811.55, and that she has justly expended in and about the administration of said estate and the payment of lawful debts, demands and charges against said estate the sum of \$60,811.55, leaving a balance of \$.00 for distribution among those entitled. And said account being full and correct, it is decreed by the Court that said accounts be, and the same are hereby, in all things passed and allowed as above stated.

It is also ordered that the Executrix pay to the Clerk of the Circuit Court of Perry County, Alabama the amount of \$38.75, which includes the final court costs and publication fee.

It is further ordered, that all accounts, vouchers, evidences and statements on file relating to this settlement, and all other papers on file respecting said estate be recorded.
