
## QUIT CLAIM DEED

Commence at the Southeast corner of the Northeast 1/4 of the Southwest 1/4 of Section 11, Township 18 South, Range 1 East, Shelby County, Alabama, and run in a Westerly direction along the South line of said 1/4-1/4Section a distance of 789.02 feet to a point on the Southeast right-ofway line of Shelby County Highway No. 50; thence turn a deflection angle way line of Shelby County Highway No. 50; thence turn a deflection angle of 111°09'00" to the right and run in a Northeasterly direction along 7 the Southeast right-of-way line of Shelby County Highway No. 50 a distance of 450.72 feet to a point; thence turn a deflection angle of 0° 32' 10" to the right and continue in a Northeasterly direction along the South-east right-of-way line of Shelby County Highway No. 50 a distance of east right-of-way line of Shelby County Highway No. 50 a distance of 193.50 feet to the point of beginning; thence turn a deflection angle of 5° 06' 20" to the right and continue in a Northeasterly direction along the Southeast right-of-way line of said Shelby County Highway No. 50 a distance of 300.00 feet to a point; thence turn an interior angle of 119° 34' 50" and run to the right in an Easterly direction a distance of 120.00 feet to a point; thence turn an interior angle of 60° 25' 10" and run to the right in a Southwesterly direction parallel to the right-of way line of Shelby County Highway No. 50 a distance of 300.00 feet to a point; thence turn an interior angle of 119° 34' 50" and run to the right in a Westerly direction a distance of 120.00 feet to the point of beginning; containing 0.719 acres, more or less.
