KNOW ALL MEN BY THESE PRESENTS, That WE, THOMAS A. ARLEDGE

AND WIFE KIM S. ARLEDGE

for and in consideration of the sum of four hundred and fifty
Dollars (\$ 450.00) to US in
hand paid by Alabama Power Company, a corporation, the receipt whereof is
hereby acknowledged, do hereby grant to said Alabama Power Company, its
successors and assigns, the right to implant, install and maintain anchors
of wood or other material at two points on the property hereinafter des-
cribed, and to construct, extend and maintain guy wires from said anchors
to structures now erected or hereafter to be erected on said land. Said
anchors and guy wires to be located on and across lands of the undersigned
in the County of Shelby, State of Alabama.

The lands of which said guy wires and anchors are to be implanted
or installed are described as follows: A parcel of land in the
Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$) and the
Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section
22, Township 22 South, Range 3 West, Shelby County, Alabama, such
point being more particularly described as follows: To reach a point
of beginning, commence at the Northeast corner of Section 22, Town-
ship 22 South, Range 3 West; thence run South along the East boundary
line of such Section 22 a distance of 1001.3 feet to a point; thence
turn an angle to the right of 40 degrees 40 minutes and run South 43
degrees 21 minutes West a distance of 256.6 feet to a point; thence
turn an angle to the right of 00 degrees 18 minutes and run South
43 degrees 39 minutes West a distance of 367.2 feet to a point; thence
turn an angle to the right of 01 degree 14 minutes and run South 44
degrees 53 minutes West a distance of 426.5 feet to a point; thence
turn an angle to the right of 01 degree 45 minutes and run South 46
degrees 38 minutes West a distance of 350.2 feet to a point; thence
turn an angle to the right of 03 degrees 15 minutes and run South
49 degrees 53 minutes West a distance of 346.5 feet to a point;
thence turn an angle to the right of 03 degrees 46 minutes and run
South 53 degrees 39 minutes West a distance of 344.7 feet to a point;
such point being called Point "A" for reference hereinafter; thence
turn an angle to the right of 01 degree 24 minutes and run South 55
degrees 03 minutes West a distance of 382.7 feet to a point; thence
run in a Southeasterly direction 70 feet to a point, such point being
called Point "B" for reference hereinafter. From said Point "B",
guy wires and anchors will extend in a Southeasterly direction. Thence
return to Point "A" heretofore indicated, from said Point "A" run
Southeasterly 70 feet to a point, such point being called Point "A-1"
for reference hereinafter. From Point "A-1", guy wires and anchors
will extend in a Southeasterly direction. Final Survey is attached hereto and
