such point being the point of beginning.

Begin at the point of beginning and continue westerly along the north
boundary of Shelby County Road #26 a distance of 250.0 feet to a point,
thence turn an angle to the right of 90 degrees 00 minutes and run
northerly a distance of 250.0 feet to a point; thence turn an angle to the
right of 90 degrees 00 minutes and run easterly a distance of 250.0 feet to
a point; thence turn an angle to the right of 90 degrees 00 minutes and
run southerly a distance of 250.0 feet to the point of beginning.

TO HAVE AND TO HOLD to the said Company, its successors and assigns, with all the rights and appurtenances thereunto belonging, forever.

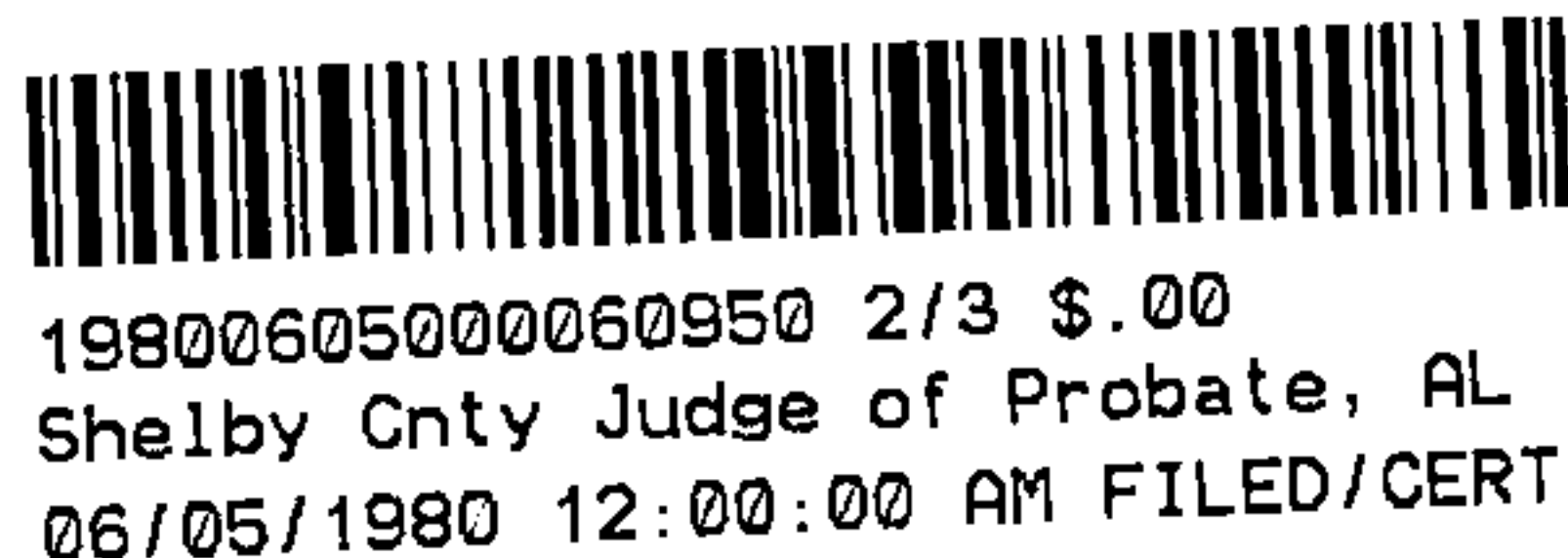
