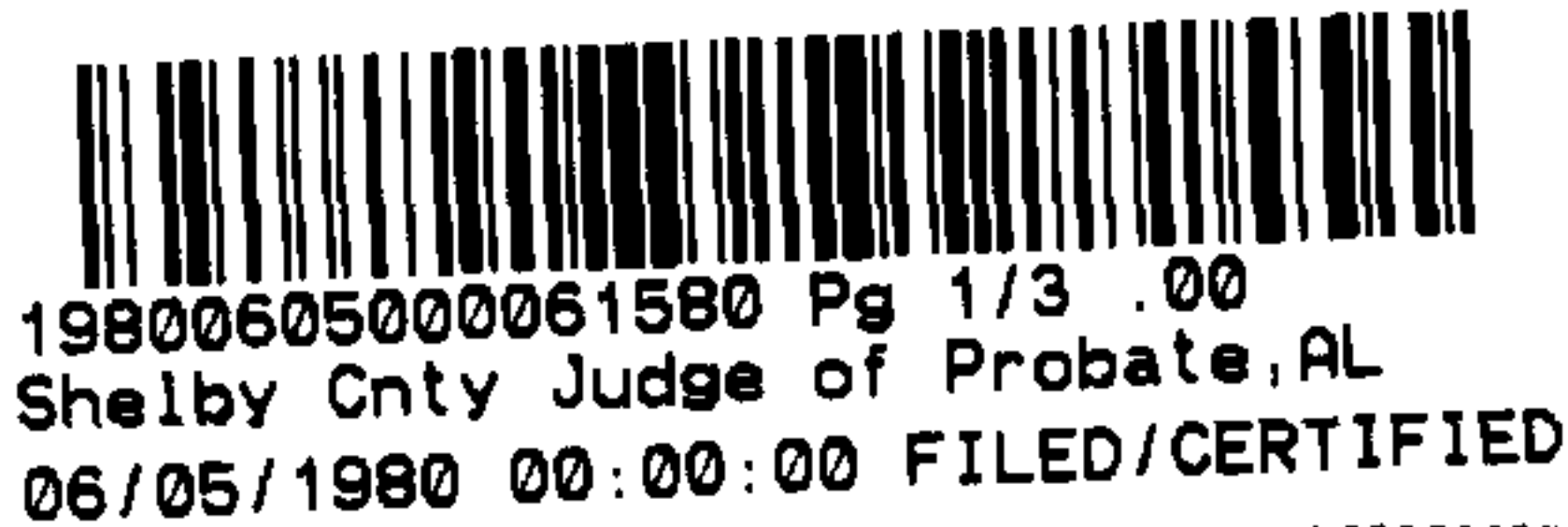

(hereinafter called the grantor,) for and in consideration of the sum of One and NO/100-----(\$1.00) Dollars, to him in hand paid by the ALABAMA POWER COMPANY, a corporation, the receipt whereof is hereby acknowledged, has granted, bargained and sold, and by these presents do es hereby grant, bargain, sell and convey unto the said ALABAMA POWER COMPANY, (hereinafter called the Company), its successors and assigns, the following described real estate, situated in the County of Shelby and State of Alabama, and described as follows:

A parcel of land situated in the southeast quarter of the southeast quarter (SE¼ of SE¼) of Section 10, Township 21 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

Commence at the southeast corner of Section 10, Township 21 South, Range 3 West; thence run north along the east boundary of such Section 10 a distance of 71.6 feet to a point; thence turn an angle to the left of 91 degrees 58 minutes and run westerly a distance of 111.82 feet to a point on the north boundary of Shelby County Road #26, such point being the point of beginning.

Begin at the point of beginning and continue westerly along the north boundary of Shelby County Road #26 a distance of 250.0 feet to a point, thence turn an angle to the right of 90 degrees 00 minutes and run northerly a distance of 250.0 feet to a point; thence turn an angle to the right of 90 degrees 00 minutes and run easterly a distance of 250.0 feet to a point; thence turn an angle to the right of 90 degrees 00 minutes and run southerly a distance of 250.0 feet to the point of beginning.

The above described lands containing in all 1.43 acres.
