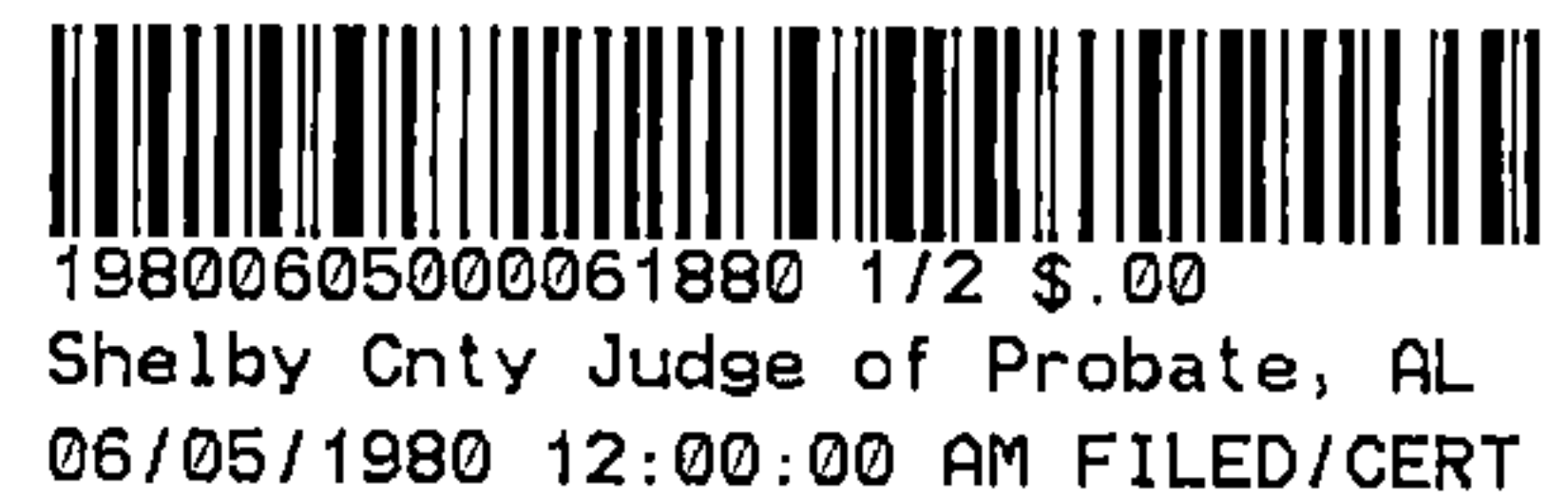


PARTIAL RELEASE OF MORTGAGE

South One-Half of Southwest Quarter of Southeast Quarter of Section 9, Township 19, Range 2 East.

All that part of the Southeast Quarter of Southeast Quarter of Section 9, Township 19, Range 2 East, lying South and West of Bakers Spring Branch.
