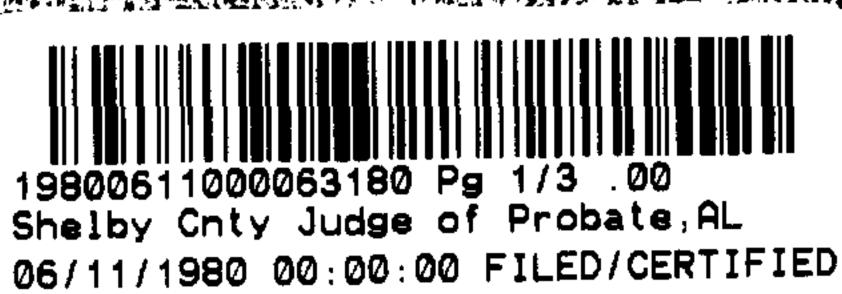

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

SHELBY COUNTY

That in consideration of One Dollar and exchange of land, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, we, BILLY RAY WATSON and wife, FRANCES S. WATSON; CATHERN W. PARKER and husband, RUDOLPH PARKER; JOHN W. WATSON and wife, VIRGINIA WATSON; DONALD M. WATSON and wife, LINDA WATSON; MARY ALICE ADERHOLT and husband, RALPH ADERHOLT; LINDA RUTH KNIGHT and husband, ROGER KNIGHT; and CHRISTINE W. MANFRE and husband, LEONARD MANFRE (herein referred to as grantors), grant, bargain, sell and convey unto WALTER MARION WATSON (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:

A tract of land located in the NE% of the NE% of Section 15, Township 18 South, Range 1 East; Commence at the Southeast corner of said \(\frac{1}{4} \) section; thence run North along the Eas line of said 1/4 section a distance of 171.65 feet to a point; thence turn left an angle of 50 deg. 00 min. 06 sec. and run in a Northwesterly direction a distance of 667.53 feet to the point of beginning of the property herein conveyed; thence continue along last described course a distance of 200 feet to a point; thence run in a Southwesterly direction a distance of 735 feet, more or less, to a point on the West line of said 1-1 section; said point being 440 feet North of the Southwest corner of said 1/4-1/4 section; thence run South along the West line of said 1/4 section a distance of 80 feet to a point; thence turn an angle to the left of 89 deg. 06 min. 24 sec. and run East 600 feet to a point; thence turn an angle of 46 deg. 03 min. 36 sec. to the left and run a distance of 325.64 feet to the point of beginning.
