MANFRE and husband, LEONARD MANFRE (herein referred to as grantors), grant, bargain, sell and convey unto CATHERN W. 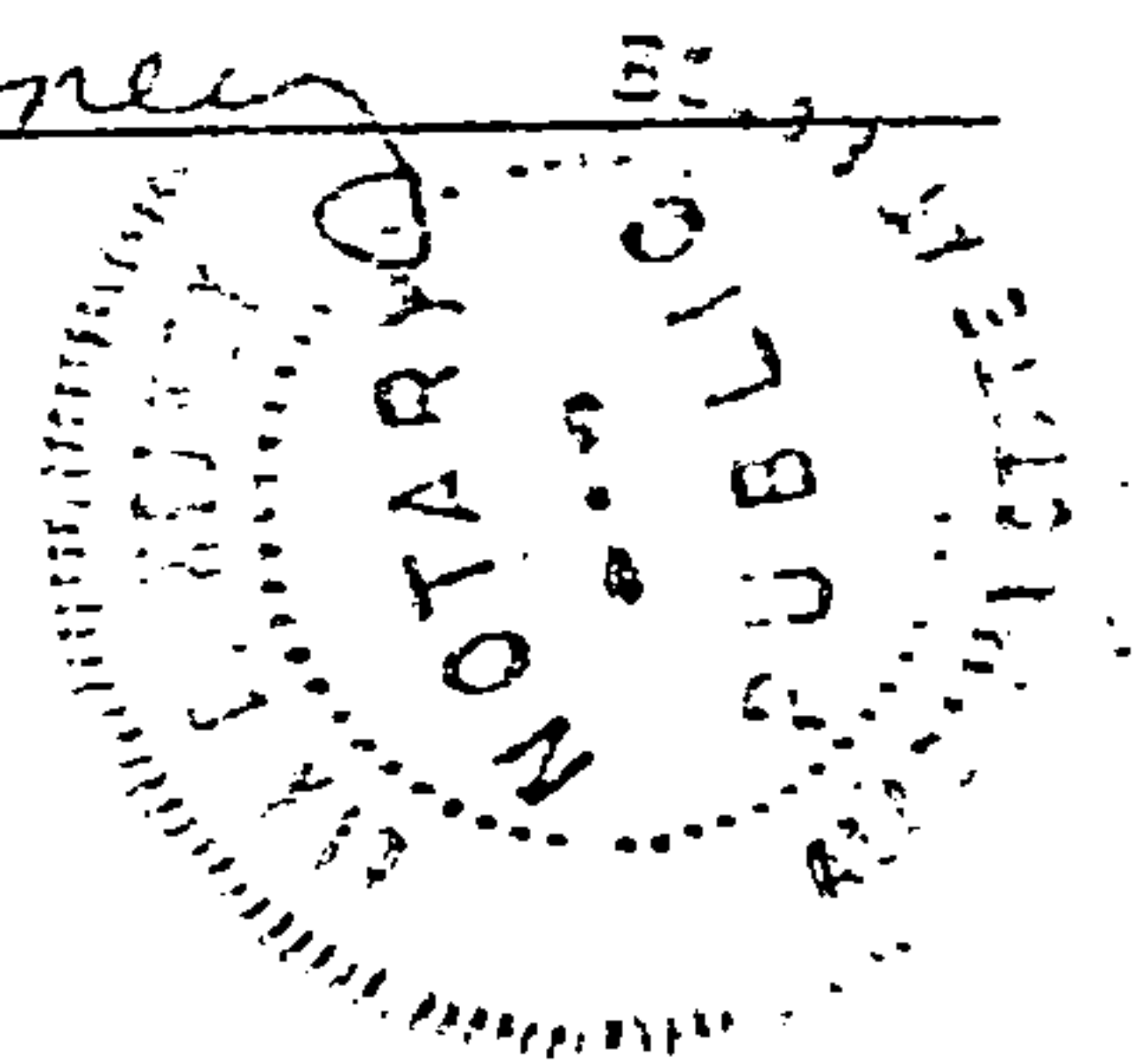
