MANFRE and husband, LEONARD MANFRE (herein referred to as grantors), grant, bargain, sell and convey unto WALTER MARION WATSON (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:
