WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

SHELBY COUNTY

That in consideration of One Dollar and exchange of land, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, we, BILLY RAY WATSON and wife, FRANCES S. WATSON; JOHN W. WATSON and wife, VIRGINIA WATSON; DONALD M. WATSON and wife, LINDA WATSON; MARY ALICE ADERHOLT and husband, RALPH ADERHOLT; LINDA RUTH KNIGHT and husband, ROGER KNIGHT; and CHRISTINE W. MANFRE and husband, LEONARD MANFRE (herein referred to as grantors), grant, bargain, sell and convey unto CATHERN W. PARKER and WALTER MARION WATSON (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:

Lots 6, 7 and a portion of 8, according to Theo Sparks Survey of the Town of Vandiver, as recorded in Map Book 3, Page 45 in the Probate Office of Shelby County, Alabama, more particularly described as follows: Commence at the point of intersection of the West right-of-way line of Shelby County Highway 43 and the North right-of-way line of the Central of Georgia Railroad; thence run in a Northwesterly direction along the North line of said railroad right-of-way a distance of 270 feet to a point; said point being designated by an iron rail; thence run in a Northeasterly direction, perpendicular to said railroad right-of-way a distance of 109 feet, more or less, to a point on the South line of U.
