WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY

That in consideration of One Dollar and exchange of land, to the undersigned grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, CATHERN W. PARKER and husband, RUDOLPH PARKER; JOHN W. WATSON and wife, VIRGINIA WATSON; DONALD M. WATSON and wife, LINDA WATSON; MARY ALICE ADERHOLT and husband, RALPH ADERHOLT; LINDA RUTH KNIGHT and husband, ROGER KNIGHT; WALTER MARION WATSON and wife, REBECCA WATSON; and CHRISTINE W. MANFRE and husband, LEONARD MANFRE (herein referred to as grantors), grant, bargain, sell and convey unto BILLY RAY WATSON and FRANCES S. WATSON, (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:

Commence at the Southwest corner of the NE $\frac{1}{4}$  of the NE $\frac{1}{4}$ , Section 15, Township 18 South, Range 1 East; thence run North along the West line of said  $\frac{1}{4}$ - $\frac{1}{4}$  Section a distance of 360.00 feet; thence turn an angle of 90 deg. 53 min. 36 sec. to the right and run a distance of 600.00 feet; thence turn an angle of 89 deg. 06 min. 24 sec. to the right and run a distance of 418.05 feet to a point on the North right-of-way of Shelby County Hwy. No. 43; thence turn an angle of 68 deg. 47 min. 33 sec. to the right and run along said Hwy. R/W a distance of 423.81 feet; thence turn an angle of 7 deg. 38 min. 33 sec. to the left and continue along said Hwy. R/W a distance of 233.84 feet; thence turn an angle of 118 deg. 51 min. to the right and run a distance of 333.55 feet to the point of beginning. Situated in the E $\frac{1}{2}$  of the NE $\frac{1}{4}$ , Section 15, Township 18 South, Range 1 East, Huntsville Meridian, Shelby County, Alabama, and containing 7.50 acres.

A portion of the above property has previously been conveyed to the grantee by deed dated June 22, 1973, recorded in Deed Book 281, page 285 in the Probate Office of Shelby County, Alabama.

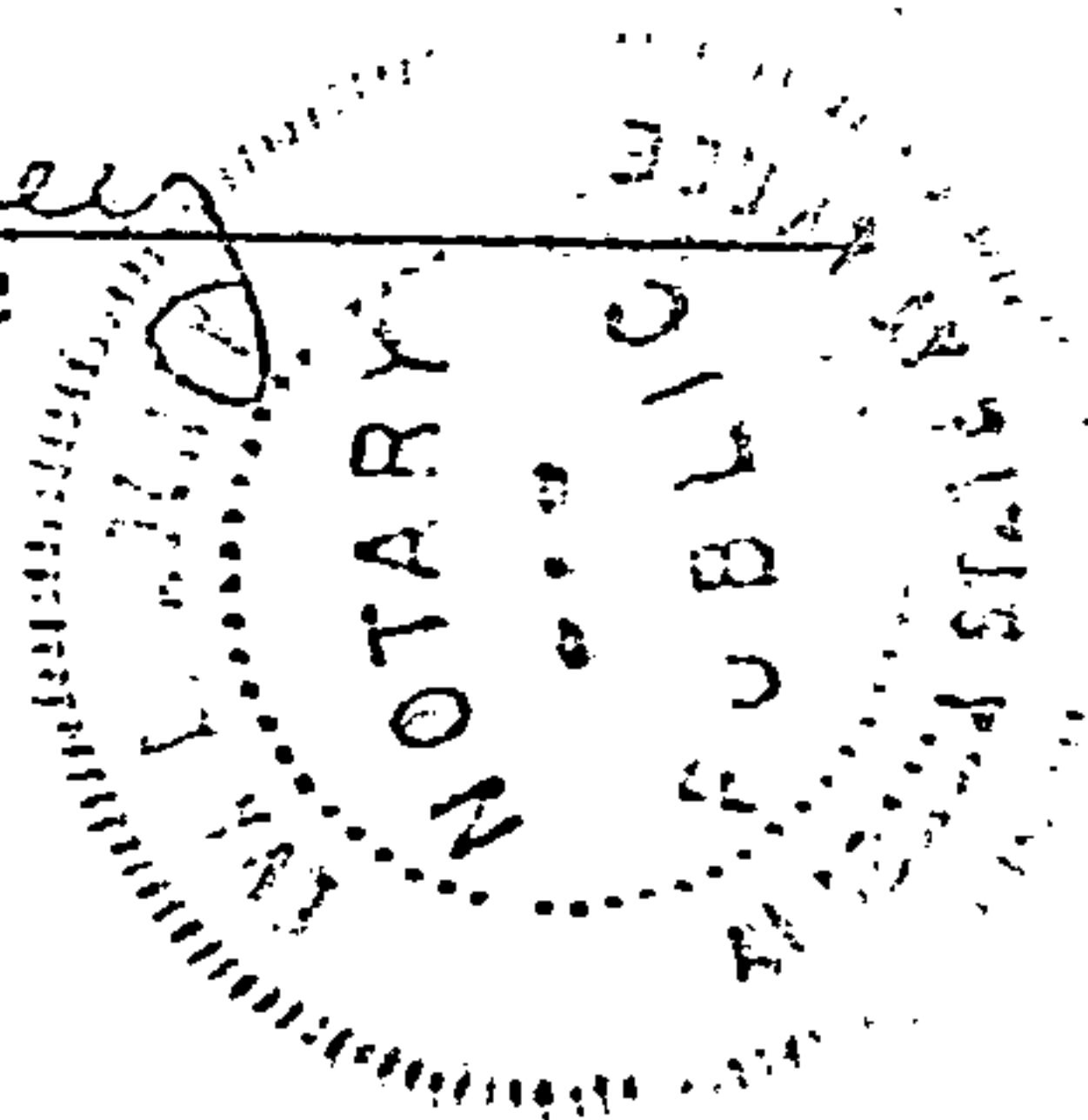
