

MANFRE and husband, LEONARD MANFRE (herein referred to as grantors), grant, bargain, sell and convey unto DONALD M. WATSON (herein referred to as grantee, whether one or more), the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:



LESS AND EXCEPT that portion of Lot 8 described as follows: Commence at the point of intersection of the West right-of-way line of Shelby County Highway No. 43 and the North right-ofway line of the Central of Georgia Railroad; thence run in a Northwesterly direction along the North line of said railroad right-of-way a distance of 270 feet to a point; said point being designated by an iron rail; thence run in a Northeasterly direction, perpendicular to said railroad right-of-way a distance of 109 feet, more or less, to a point on the South line of U.
