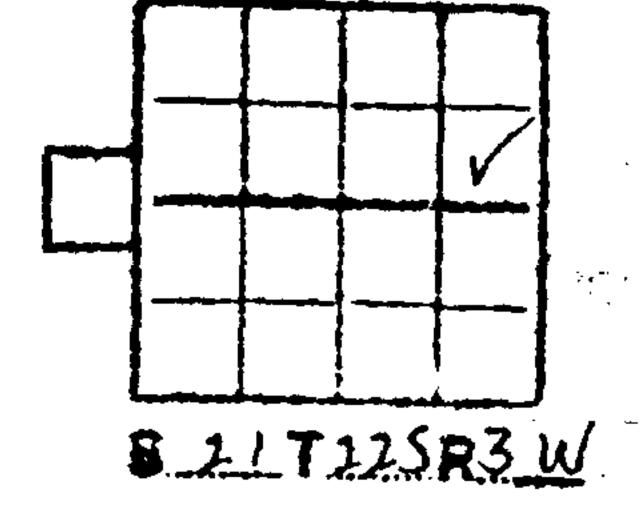

South, Range 3 West, more particularly described as follows:

Tract A: Commence at the northeast corner of said forty, thence west

200 feet along the north line of said forty for a point of beginning,
thence 92° 13' left 277.97 feet, thence 91° 45' right 331.50 feet,
thence 90° right 284.37 feet to the north line of said forty, thence
east 325.95 feet along said north line to the point of beginning.

Tract B: Commence at the southeast corner of Lot 19, Bridlewood Forest
Subdivision, as recorded in Map Book 5, Page 52, Probate Office, Shelby
County, for a point of beginning, thence east 335 feet along the north line
of Olverland Road, thence north 277.20 feet along the west line of
Comanche Road, thence west 331.50 feet to a point on the east line of
Lot 17 of said subdivision, said point being 270.44 feet north of the
point of beginning, thence south 270.44 feet along the east line of
Lot 17, Lot 18, Lot 19, of said subdivision to the point of beginning.
