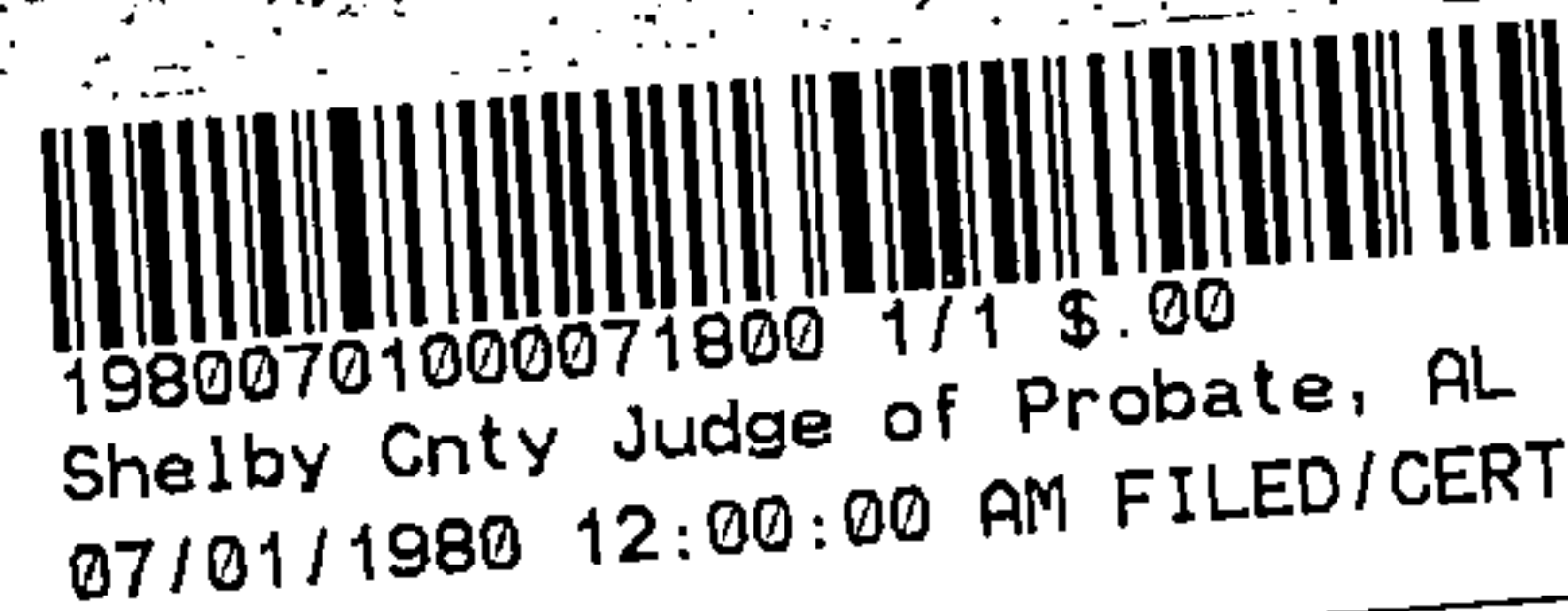

PARTIAL MORTGAGE RELEASE



KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, George W. Porter, Jr. and wife, Fay Harvey Porter, did heretofore execute a certain mortgage in favor of Kathryn Purdy and Margery Purdy as shown by mortgage recorded in Mortgage Book 333, page 178 in the Probate Office of Shelby County, Alabama; and

WHEREAS, Jerry W. Brown and wife, Kathryn Brown, did heretofore execute a certain mortgage in favof of Kathryn Purdy and Margery Purdy as shown by mortgage recorded in Mortgage Book 369, page 299 in said Probate Office, said mortgages conveying the real estate as described therein as security for the payment of an indebtedness designated in said mortgage; and,

WHEREAS, a portion of the indebtedness secured by said mortgages has now been paid in full to said mortgagees;

NOW, THEREFORE, said mortgagees, for and in consideration of these premises, and for and in consideration of the further sum of One Dollar (\$1.00) to them in hand paid, the receipt whereof is hereby acknowledged, do hereby release and discharge from the terms and conditions of said mortgages designated above and from the encumbrances of said mortgages, the following described land, located in Shelby County, Alabama, to-wit:

A part of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$, Sec. 21, Township 18 South, Range 1 East, Shelby County, Alabama, said part being more particularly described as follows:

From the SE corner of said SW $\frac{1}{4}$ of SW $\frac{1}{4}$ run West along South line of said $\frac{1}{2}$ $\frac{1}{4}$ Section for a distance of 828.65 feet to a point on the Southeast line of the 80 foot wide right of way of Shelby County Highway No. 43; thence turn an angle to the right of 128 deg.08' and run in a Northeasterly direction along said SE right of way line for a distance of 691.72 feet to the point of beginning of the property herein described; thence continue Northeasterly along said right of way line for a distance of 50 feet; thence turn an angle to the right of 89 deg.56' and run Southeasterly for a distance of 169.23 feet; thence turn an angle to the right of 9 deg. 15' and run Southeasterly for a distance of 268.82 feet; thence turn an angle to the right of 126 deg. 13' and run Southwesterly for a distance of 194.44 feet; thence turn an angle to the right of 68 deg. 10' and run Northwesterly for a distance of 323.12 feet to the point of beginning; containing 1.00 acre, more or less.

It is understood that the above designated mortgages are separately and severally preserved in full force and effect in all of its original terms and conditions as to the balance or remainder of the lands described in said mortgages and not herein specifically described, and which have not heretofore been specifically released from the terms and provisions of said mortgages.
