To have and to hold the above granted easement unto South Central Bell Telephone Company, its successors and assigns forever.

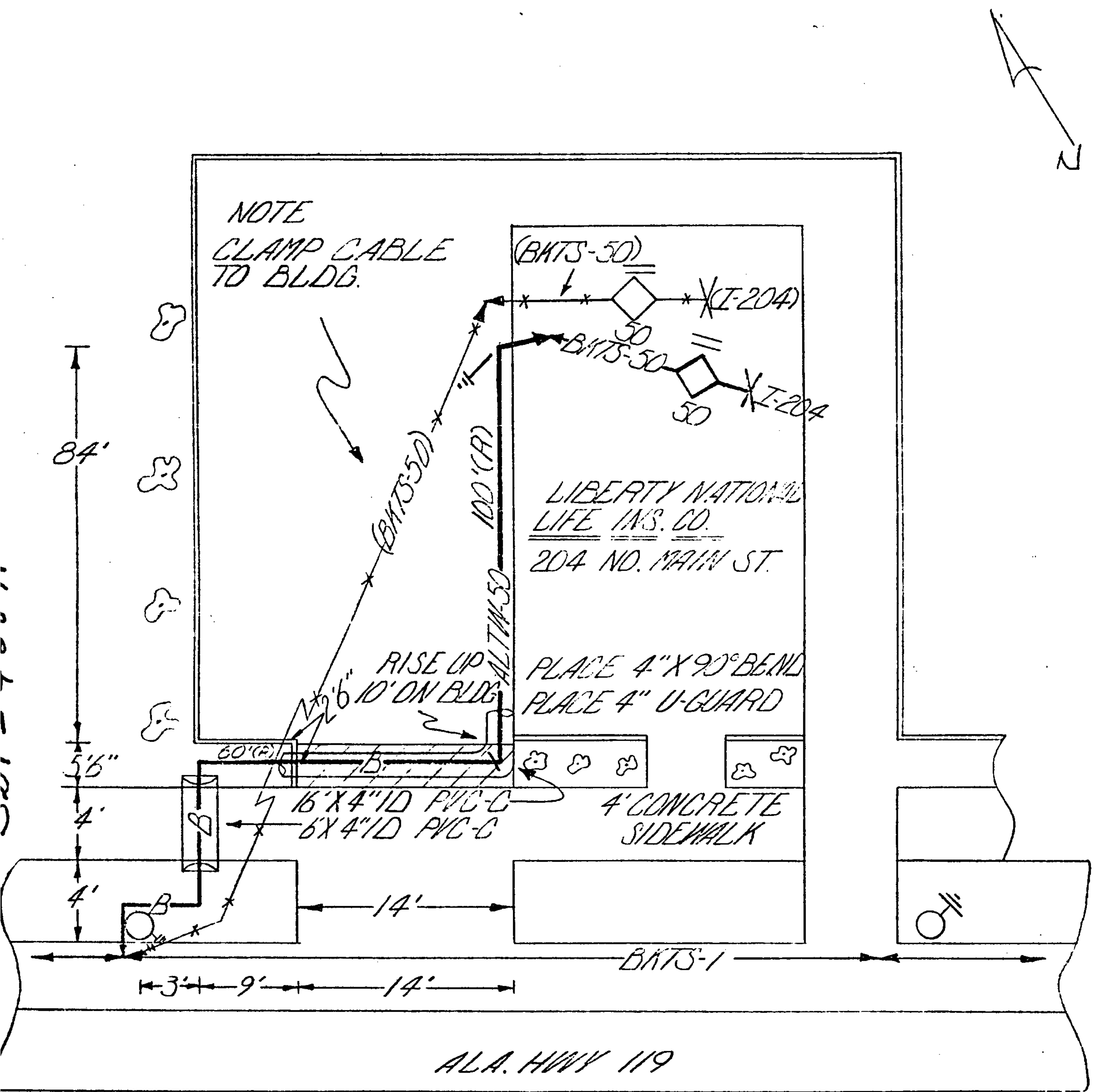
