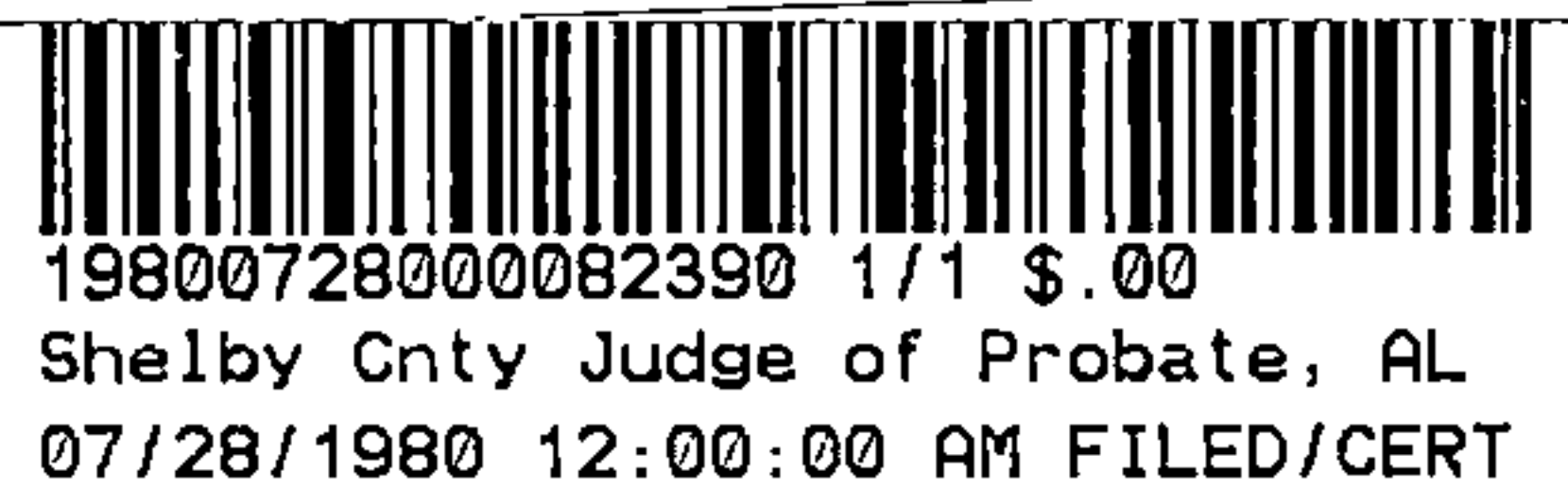
Provided however, the debt in connection herewith, as well as any other mortgages, liens or privileges securing said debt, are not discharged or in any manner affected hereby.

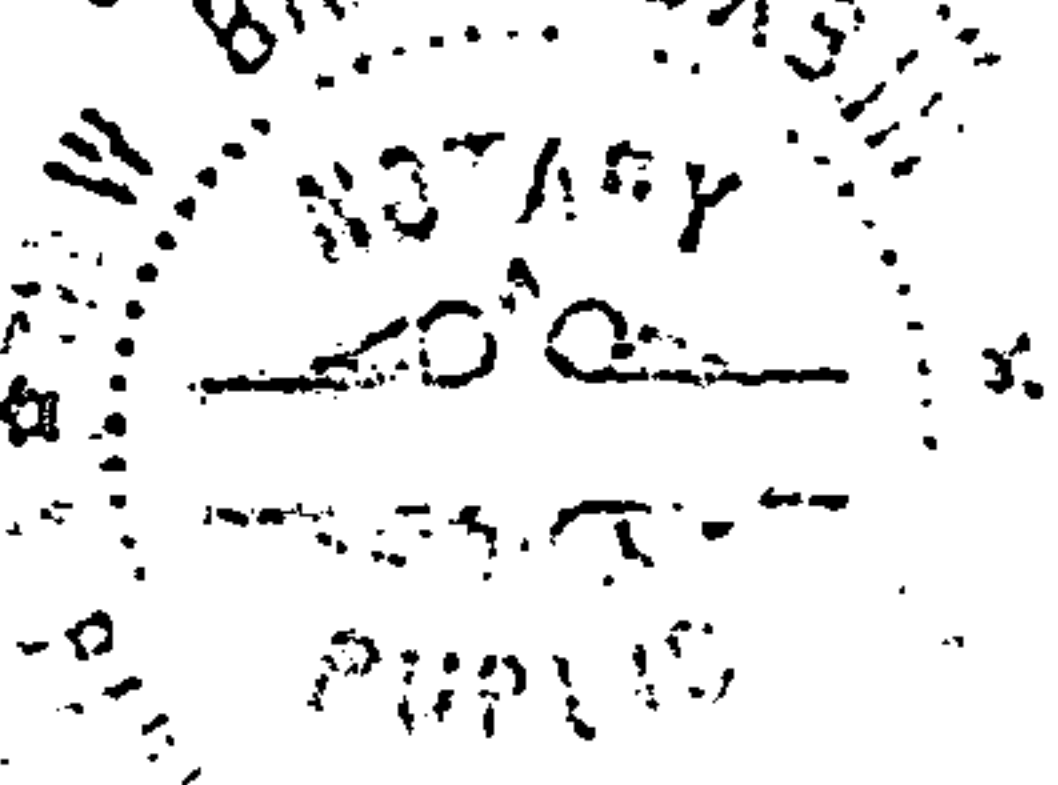
