situated in Shelby County, Alabama:

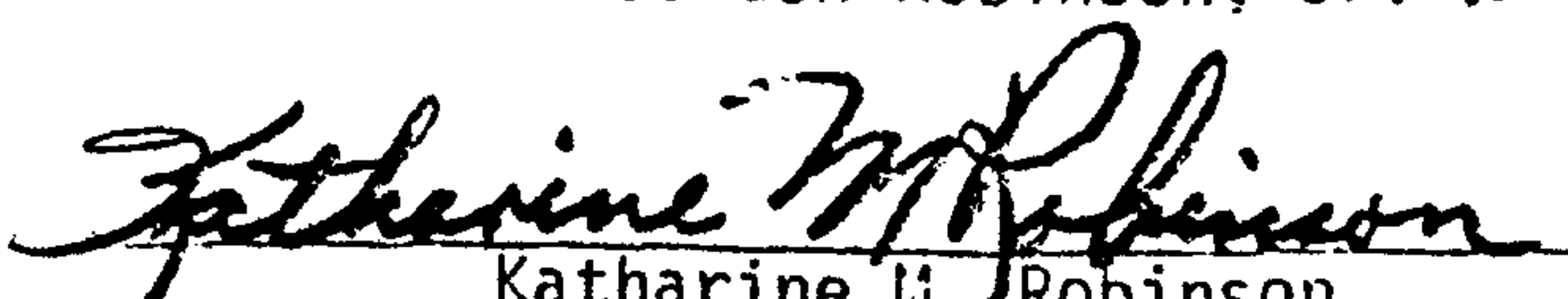
SE 1/4 of SE 1/4 of NE 1/4 of Section 11, Township 19

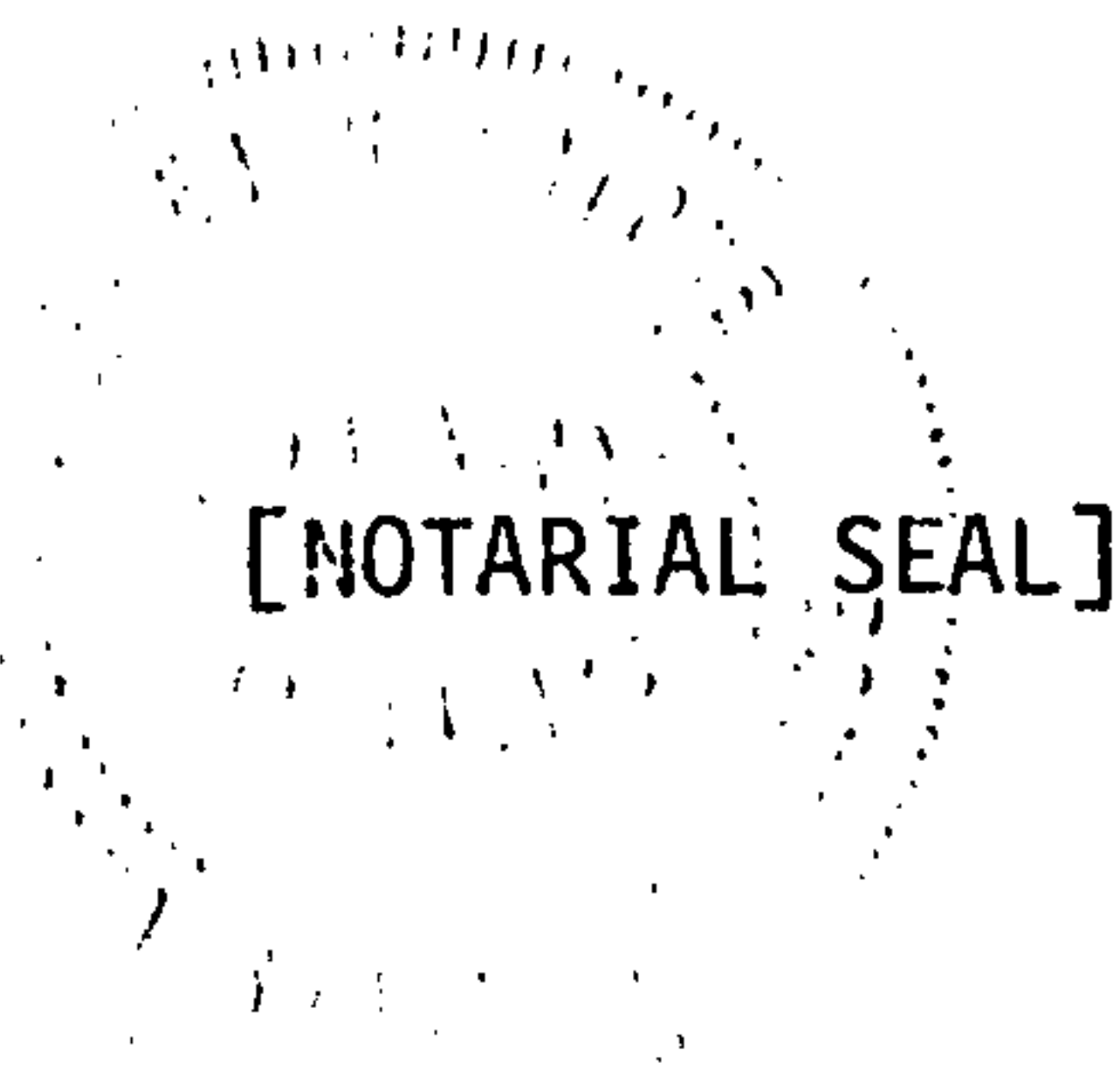
