

SE 1/4 of SE 1/4 of NE 1/4 of Section 11, Township 19 South, Range 2 West, except minerals and mining rights, less and except that part thereof described as follows: Commence at the southeast corner of the SE 1/4 of NE 1/4, Section 11, Township 19 South, Range 2 West; thence run West along the south line of said 1/4-1/4 section 660 feet to a point; thence turn 90 degrees to the right and run 153.85 feet; thence turn 58 degrees 24 minutes to the right and run 774.96 feet; thence turn 121 degrees 37 minutes to the right and run 560 feet to the point of beginning;

TO HAVE AND TO HOLD unto the Grantee, its successors and assigns forever, subject only to the lien for ad valorem taxes for the current tax year and easements and rights-of-way of record or in use.

This is a deed of correction given to correct an error in the aforesaid deed and to perfect the title to said real estate in the Grantee.
