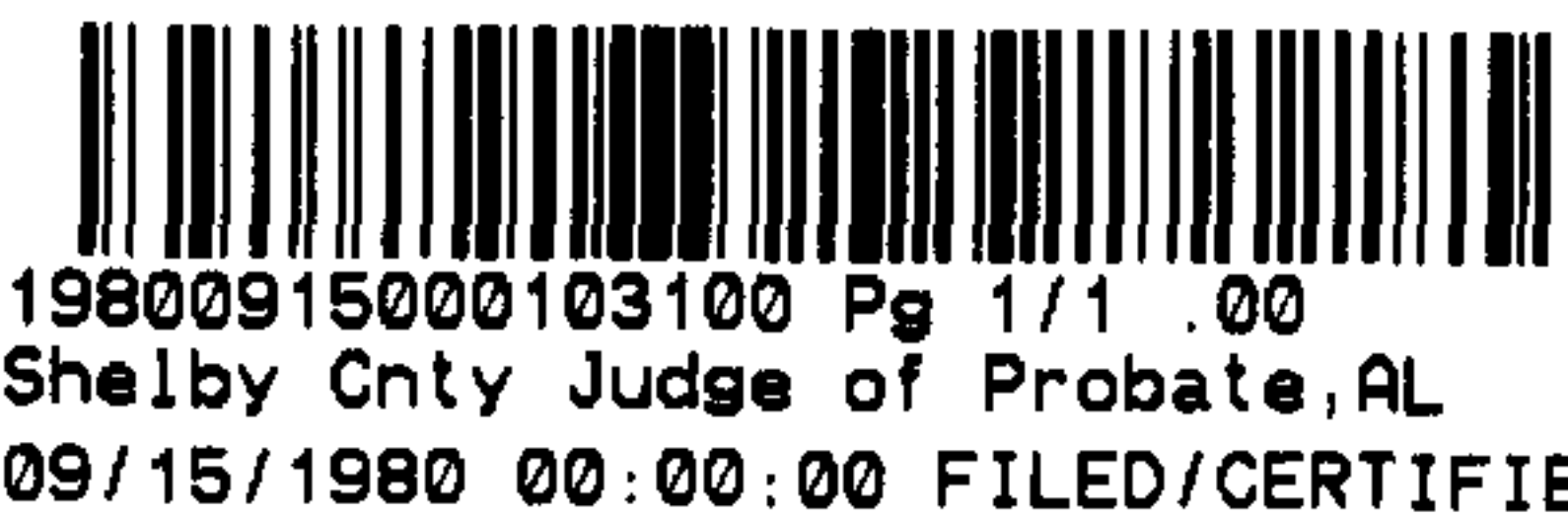
Corporation Form Warranty Deed

(herein referred to as GRANTOR) in hand paid by the grantee herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto Shelby County Unit of the Alabama Association for Retarded Citizens

(herein referred to as GRANTEE, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

A parcel of land situated in the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 2, Township 21 South, Range 3 West, more particularly described as follows: Commence at the southeast corner of the SE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 2, Township 21 South, Range 3 West and run west along the south line of said  $\frac{1}{4}$ - $\frac{1}{4}$  section for 386.59 feet; thence 98 deg. 28 min. 40 sec. right and run northeasterly for 362.18 feet; thence 89 deg. 07 min. left and run northwesterly for 150.11 feet; thence 90 deg. 11 min. 30 sec. right and run northeasterly along the centerline of 6th Street for 463.13 feet to its intersection with the centerline of 11th Avenue S. W.; thence 90 deg. 13 min. left and run northwesterly along the centerline of 11th Avenue SW for 288.81 feet; thence 90 deg. 00 min. right and run northeasterly for 30 feet to the northerly right of way line of 11th Avenue SW and the point of beginning; thence 90 deg. 00 min. left and run northwesterly along the northerly line of said right of way for 161.94 feet to the easterly right of way line of the Louisville-Nashville Railroad and the beginning of a curve to the right having a radius of 1860.08 feet; thence 89 deg. 32 min. 09 sec. right to tangent of said curve and run northeasterly along the arc of said curve and along said right of way line for 141.64 feet; thence 30 deg. 35 min. 04 sec. right from tangent of said curve and run northeasterly along a right of way line for a Public Road for 38.95 feet to the beginning of a curve to the left having a radius of 248.11 feet; thence northeasterly along the arc of said curve and along said right of way for 41.28 feet; thence 76 deg. 30 min. 20 sec. right from tangent of said curve and run southeasterly for 118.34 feet; thence 78 deg. 41 min. 55 sec. right and run southwesterly for 184.17 feet to the point of beginning.
