

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Dollar and no/100 (\$1.00) Dollars to the undersigned grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, WILLIAM HOWARD CARDEN, a single man; OTIS HAROLD CARDEN and wife, MAMIE CARDEN; RUBY CARDEN, a single woman; GORDON E. CARDEN and wife, SHELIA CARDEN; HELEN BUSH and husband, MORRIS BUSH; PATRICIA WHITE and husband, ONEAL WHITE; FAYE HORTON, a single woman, (herein referred to as grantors) do grant, bargain, sell and convey unto EDGAR WILSON and 0 ADA MAE WILSON, (herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

A portion of Block 1 according to Safford's Survey of the Town of Shelby recorded in Map Book 3, Page 38, Probate Office, Shelby County, being located as shown herein and more particularly described as follows:

Commence at the Southwest corner of Block 1 of said Safford survey; thence proceed in a Northerly direction along the East boundary of Church Street for 215.00 feet to a point, being the point of beginning of the parcel of land herein described; thence continue along the East boundary of Church Street for 177.36 feet to a point; thence turn 98 degrees 23 minutes 22 seconds right and run 134.52 feet to a point; thence turn 88 degrees 29 minutes 50 seconds right and run 173.14 feet to a point; thence turn 90 degrees 17 minutes 35 seconds right and run 113.21 feet to the point of beginning. Said parcel contains 0.50 acres. Situated in Shelby County, Alabama, and subject to any easements and rights-of-way of record.

TO HAVE AND TO HOLD to the said Grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.
