

(5) Sign, seal, execute, acknowledge and deliver such deeds, leases and assignment of leases, agreements, mortgages, releases and satisfaction of mortgages and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises.

(6) Giving and granting unto Amy Jean Rader, as my true and lawful attorney, full power and authority to do and perform all and every act and thing whatsoever requisite
