Whereas, on November 3, 1980, Donald N. Lathem and Wife, Margaret Erwin Lathem executed a Vacation of Alley which was duly assented to and approved by the Town Council of the Town of Alabaster on November 3, 1980, and recorded in Book 38, Page 182, in the Office of the Judge of Probate of shelby County, Alabama.

Said Declaration of Vacation of Alley and the Resolution passed by the Town of Alabaster as recorded, contained a legal description of a part of an alley which was vacated, and the description erroneously described property in Block 30 when the alley vacated is in Block 3. The correct legal description of the alley vacated is located in Shelby County, Alabama and more particularly described as follows:

A 20 foot wide alley being 20 feet wide by 200 feet long lying East of Lots 12,13,14 and 15, and West of Lots 32,33,34 and 35, all in Block 3, Nickerson-Scott Survey as recorded in Map Volume 3, Page 34, in the Office of the Judge of Probate of Shelby County, Alabama.

The purpose of this Corrective Instrument is to correct this scrivener error in said instruments as originially recorded.



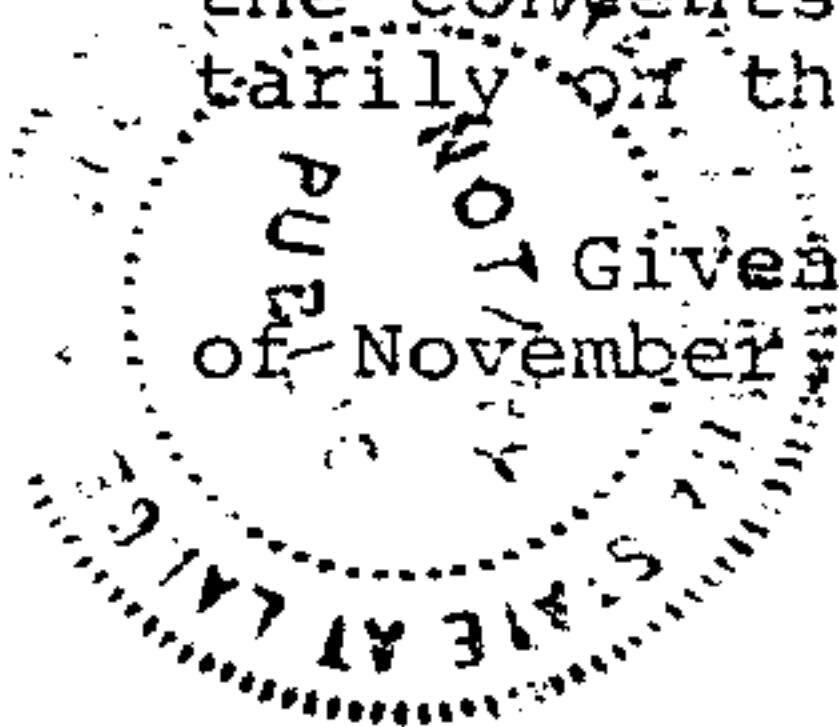


