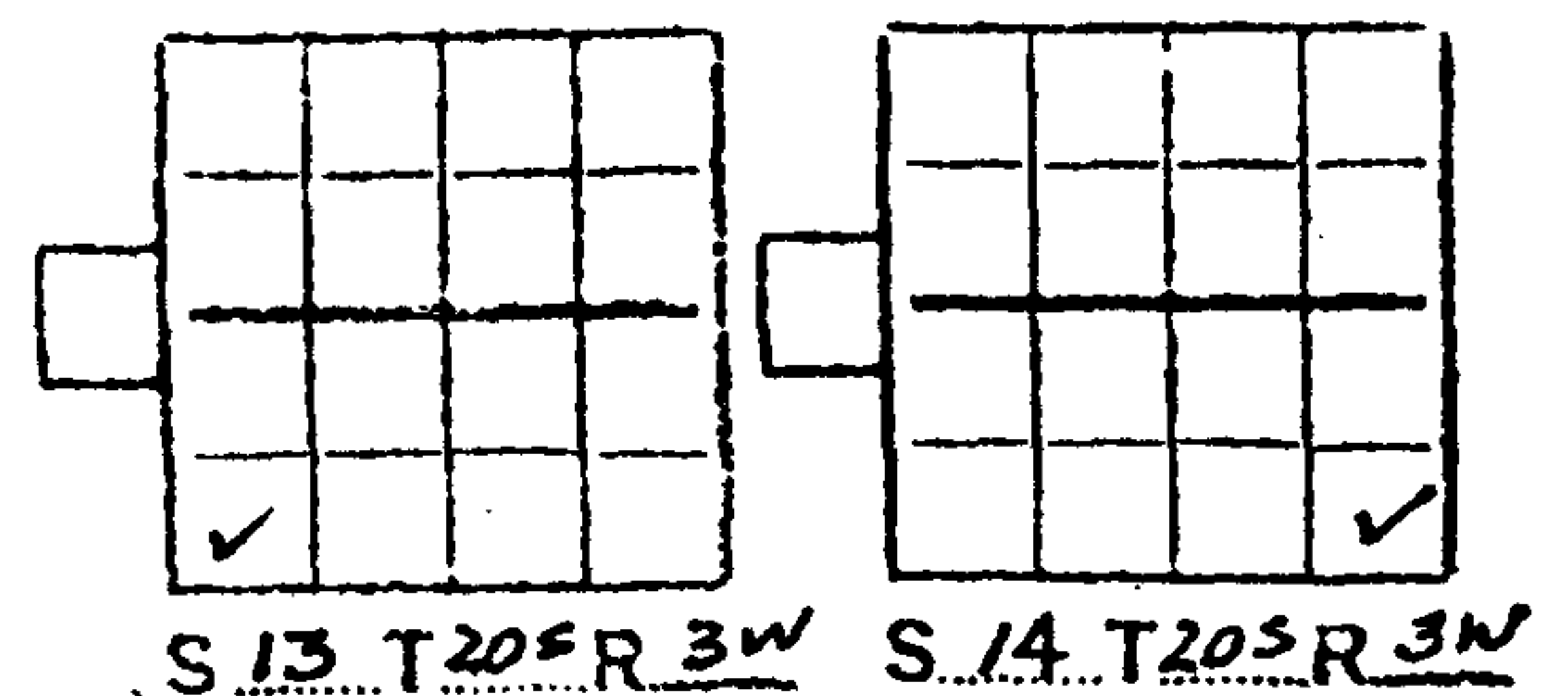
KNOW ALL MEN BY THESE PRESENTS, that the undersigned,

in connection therewith for the overhead and underground transmission and distribu-
tion of electric power and for the overhead and underground communication service,
upon, over, under and across the following described land, situated in _____

Shelby County, Alabama:

That part of the North 250 Ft. of the Southeast $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 14,
Township 20 South, Range 3 West which lies East of the Old Montgomery Highway. Also,
that part of the North 250 Ft. of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 13,
Township 20 South, Range 3 West, which lies West of U.S. Highway 31 South.

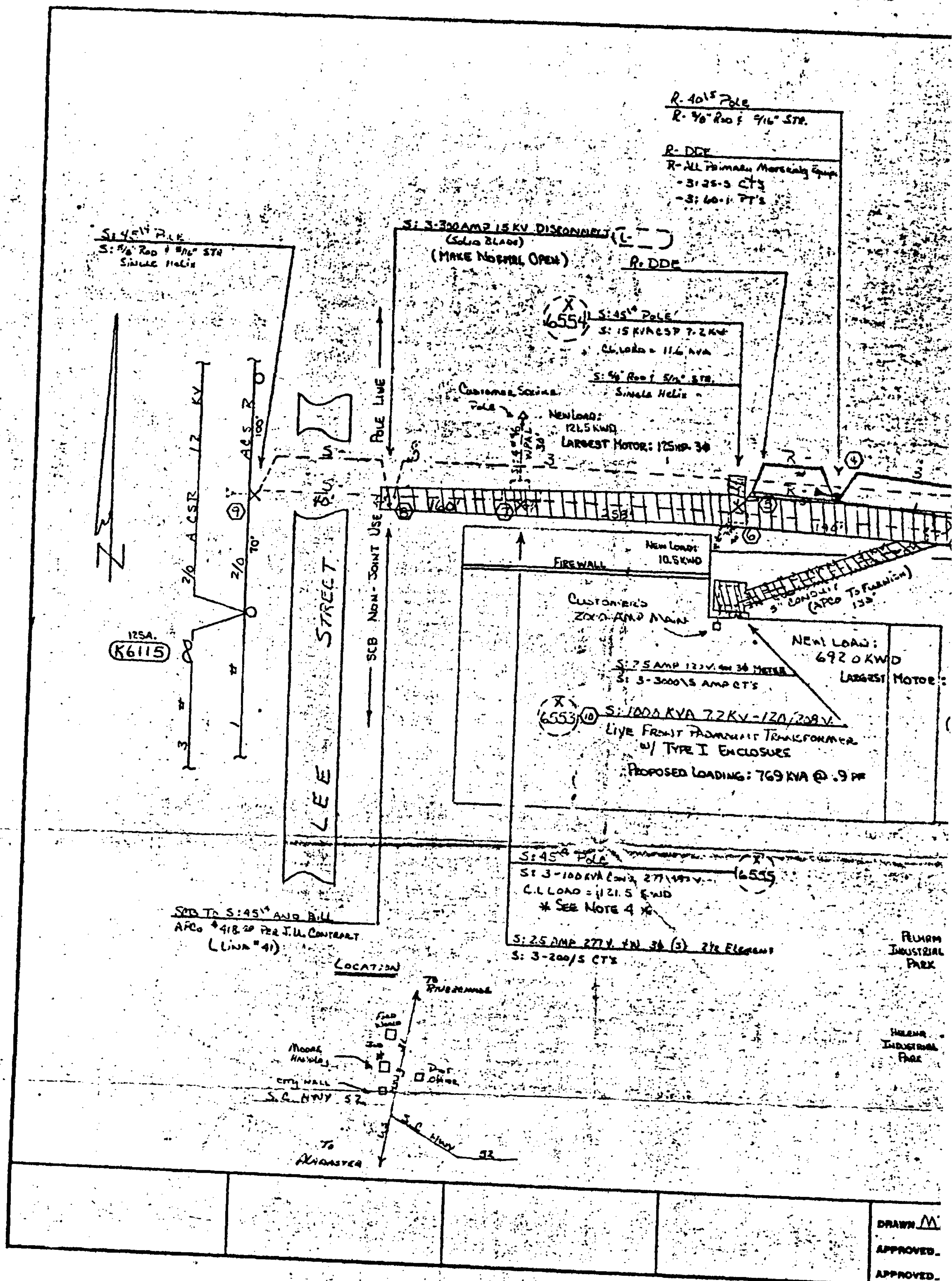
