Together with all and singular the rights, members, privileges, hereditaments, easements, and appurtenances thereunto belonging or in anywise appertaining; to have and to hold the same forever. Should Mortgagor sell, convey, transfer or dispose of, or further encumber property, or any part thereof, without the written consent of Mortgagee

being first had and obtained, then Mortgagee shall have the right, at its option, to declare all sums secured hereby forthwith due and payable.

If the mortgage shall perform all the covenants and agreements herein contained, then these presents shall be void; otherwise they shall remain in full force and effect.
