WITNESSETH, that the party of the first part being indebted to the party of the second part in the sum of \$7,053.59
Seven-thousand fifty-three and 59/100. DOLLARS,
together with interest as set out in said note
due by one promissory note(s) of this date in the amount of \$7,053.59 together with
interest at rate as set out in said note and due May 19, 1981

and being desirous of securing the payment of the same, and in consideration thereof, ha he granted, bargained, sold and
conveyed and by these presents do they grant, bargain, sell and convey to the said party of the second part the property
hereinafter described — that is to say, situated in the County of Shelby, in the State of Alabama, and
more particularly known as

Commencing at the NE corner of the N¹/₂ of the SE¹/₄ of Section 12, Township 24,
Range 15 East, run West along the North line of said 1-1/₄ section for a distance
of 418.4 feet to a point on the West side of a public road; thence turn left and
run on a bearing of South 46 West for a distance of 151.8 feet; thence turn right
and run on a bearing of South 49 deg. 30 min. West and run for a distance of
270.00 feet, more or less, to the point of beginning of the land hereby conveyed;
thence turn right and run on a bearing of North 3 deg. 30 min. West for a distance
of 25.0 feet; thence turn left and run on a bearing of South 46 deg. 20 min. West
for a distance of 150.00 feet; thence turn left and run on a bearing of South
3 deg. 30 min. East for a distance of 50.0 feet; thence turn an angle to the left,
of 90 deg. and run for a distance of 65.0 feet, more or less to a point on the
West boundary line of a public road; thence turn left and run in a northeasterly
direction along said West boundary line of said public road for a distance of

TO HAVE AND TO HOLD to the said party of the second part, its successors and assigns, forever. But this Deed is intended to operate as a Mortgage and is subject to the following condition -- that is to say, if the party of the first part shall pay and satisfy the debt above described and any other indebtedness to the owner or holder hereof as described on page 1 of this mortgage at the time or before the same falls due, then this conveyance shall be null and of no effect, but on default of the payment of any installment of the indebtedness or the interest thereon secured hereby, all of the indebtedness shall become due and payable, then the said party of the second part, its successors, or assigns, may take the above-described property into possession, and having or not having the same in possession, may sell the same to the highest bidder, at public auction at Columbiana, Alabama, for cash, having advertised such sale in some newspaper published in said County by three weekly insertions, or by posting at three public places in said County for not less than twenty days at the option of the mortgagee, and execute titles to the purchaser at said sale, and shall apply the proceeds to the payment of the expenses incident to said sale, including all costs of collection, taking possession of and caring for said property, and all attorney's fees, and the payment in full of the said demand hereby secured, and pay over the remainder, if any, to the said party of the first part. And it is further agreed that the mortgagee may buy the above described property at said sale, and the auctioneer crying the same may execute titles to the purchaser. It is further agreed that the party of the first part shall insure the buildings on said property in some good and responsible fire insurance company for a sum equal to the indebtedness hereby secured, with loss, if any, payable to the party of the second part as _____ interest may appear.
