J U D G M E N T O F P O S S E S S I O N

THE COURT CONSIDERING the Petitions, Affidavits, Tableau of Distribution, the clearance showing payment of all Louisiana Inheritance Taxes due herein and the acceptance of the Succession by the sole heir at law, together with the applicable law, the law and the evidence being in favor thereof for reasons this day orally assigned;

IT IS ORDERED, ADJUDGED AND DECREED that no Louisiana Inheritance Taxes are due herein, the same having been paid.
