
COUNTY OF SHELBY



THIS INDENTURE made and entered into on this the 24th day of October, 1980, by and between William Thomas Williams, Jr. and wife, Patsy Acton Williams, herein referred to as Grantors and James P. Morrow, Jr. and wife, Lucy M. Morrow, herein referred to as Grantees.

WITNESSETH: That the Grantors for and in consideration of Two Hundred Sixty-Six Thousand Seven Hundred Fifty and No/100 (\$266,750.00) Dollars cash in hand paid, the receipt of which is acknowledged, have this day given, granted, bargained, sold and conveyed and do by these presents give, grant, bargain, sell and convey to the Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them, in fee simple, together with every contingent remainder and right of reversion, the following described real estate, lying and being situated in the County of Shelby . State of Alabama to-wit:

Commence at the Northwest corner of the Southeast Quarter of Southeast Quarter, Section 2, Township 21 South, Range 1 East, and run thence Easterly along the North boundary of said Quarter-Quarter Section 660 feet to East boundary of West Half of Southeast Quarter of Southeast Quarter; thence south along said east boundary of West Half of Southeast Quarter of Southeast Quarter to a point which is 160 feet North of the intersection of the East boundary of said West Half of said Southeast Quarter of Southeast Quarter with Alabama Highway No. 25; thence turn an angle of 90 degrees to the right and run thence 100 feet to point of beginning of the lot herein described and conveyed, which said point constitutes the Northeast corner of the Flora Mae Reach lot; thence continue West in the same direction along the North boundary of said Reach Tilot 100 feet to a point; thence turn an angle of 90 degrees to the right and run To thence Northerly and parallel with the East boundary of said West Half of Southeast ·Quarter of Southeast Quarter to the North boundary of said Scutheast Quarter of Southeast Quarter; thence Easterly along the North boundary of said Southeast Quarter B of Southeast Quarter, 100 feet; thence turn an angle of 90 degrees to the right and run thence Southerly to the point of beginning.
