KNOW ALL MEN BY THESE PRESENTS: That the undersigned VULCAN MATERIALS COMPANY, a corporation organized under the laws of the State of New Jersey (hereinafter called "Grantor"), for and in consideration of \$220,000.00, cash in hand paid, the receipt and sufficiency of which is hereby acknowledged, does hereby grant, sell and convey unto SOUTHERN NATURAL GAS COMPANY, a corporation organized under the laws of the State of Delaware, (hereinafter called "Grantee"), its successors and assigns, a right of way and easement 60 feet in width (to be located by Grantee as hereinafter provided) for the purposes of, presently and from time to time in the future, constructing, maintaining, operating, repairing, increasing the number of, replacing and/or removing a pipeline or pipelines (and appurtenances thereto) for transportation of gas, oil or other substances and commodities, on, over and through the following described lands situated in the County of Shelby, State of Alabama, to wit:

The Southwest Quarter of Southwest Quarter of Northeast Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of NE $\frac{1}{4}$) and that part of the Northwest Quarter of Northwest Quarter of Southeast Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of SE $\frac{1}{4}$) which lies North of County Road. Also that part of the East Half of Northwest Quarter (E $\frac{1}{2}$ of NW $\frac{1}{4}$) which lies North of County Road, LESS AND EXCEPT the West 10 acres of the Northeast Quarter of Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) and all that part of the Southeast Quarter of Northwest Quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$) that lies Northwest of Dry Creek; all in Section 18, Township 22 South, Range 2 West, Shelby County, Alabama.

The center line of said right of way and easement shall be a line parallel to and at a distance of 15 feet, as measured in a westerly direction, from the center line of the first pipeline to be constructed hereunder by Grantee on the lands above described, the route of which pipeline is shown in red on copy of Southern Natural Gas Company Drawing No. P-5-82-1R, which is attached hereto, marked "EXHIBIT A" and made a part hereof.

Grantee shall not be liable for damages caused by clearing and keeping clear said right of way of trees, undergrowth and other obstructions in the course of the construction, maintenance and operation of its said pipeline and appurtenances; however, Grantee shall be liable for damages sustained by Grantor as a result thereof outside the limits of said right of way.

Grantor reserves the right to use the right of way granted herein in any manner not inconsistent with the rights granted herein to Grantee. Grantor shall not commit any act which will impair or diminish the rights conveyed to Grantee herein. Grantor shall not unreasonably interfere with the use of the right of way or obstruct the same.

For the determination of said right of way and the full enjoyment or use of the rights and easements herein granted, this grant shall include, without limitation, the further easement and right of ingress and egress over and across said lands and other adjacent lands of the Grantors, and the use thereof reasonably necessary in connection with the construction, maintenance, repair, or replacement of pipelines on said right of way; together with the right, from time to time, to cut and keep clear all trees, undergrowth and other obstructions, whether on said right of way or not, that may injure or endanger any of said lines, appliances, appurtenances, fixtures and equipment, or that it may be necessary or convenient to cut or remove in the location or determination of said right of way or in the use or enjoyment of any of the rights, interests or estates hereby conveyed.

TO HAVE AND TO HOLD the estate, easements, rights and privileges hereby conveyed to said Grantee, its successors and assigns, forever.

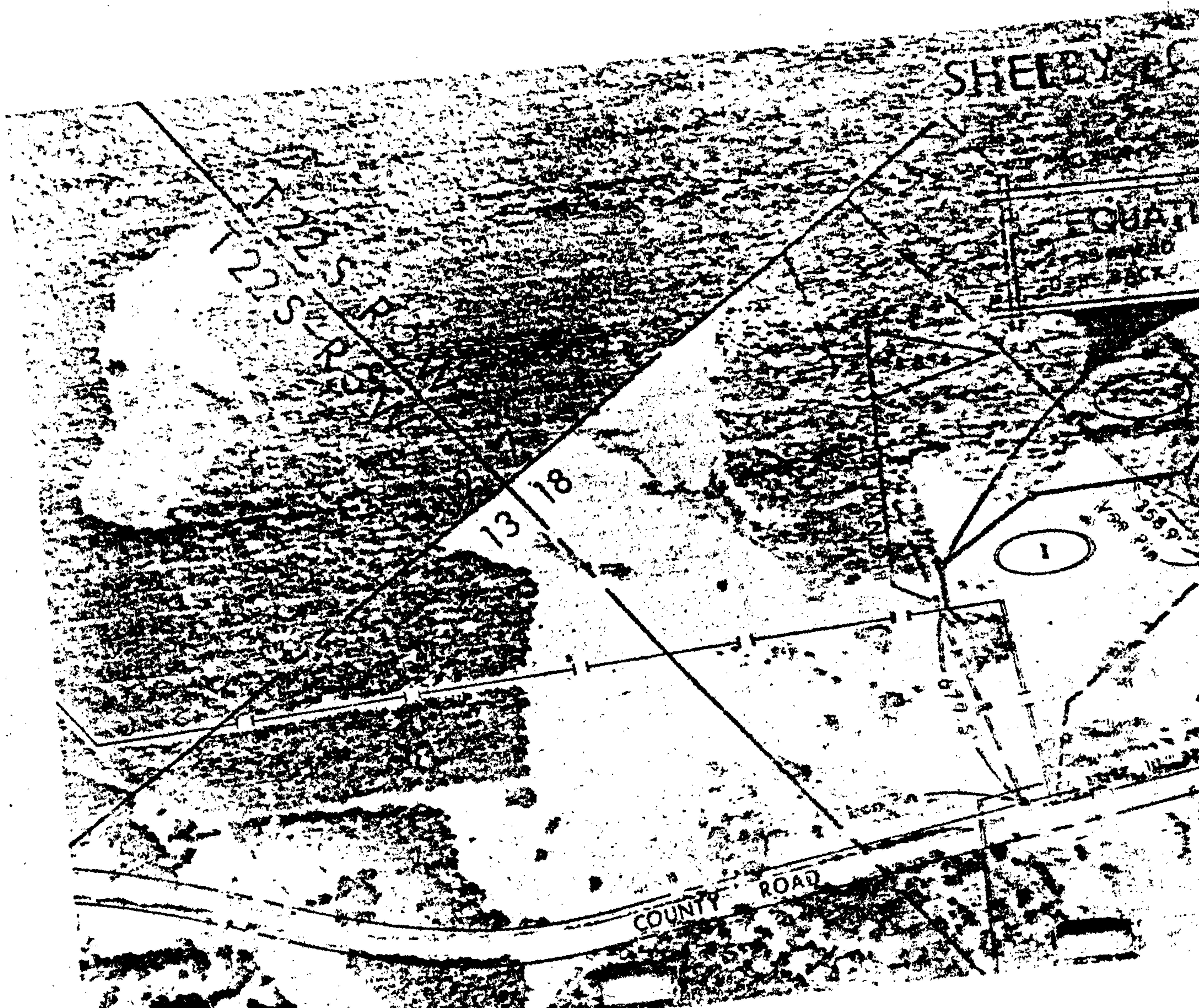

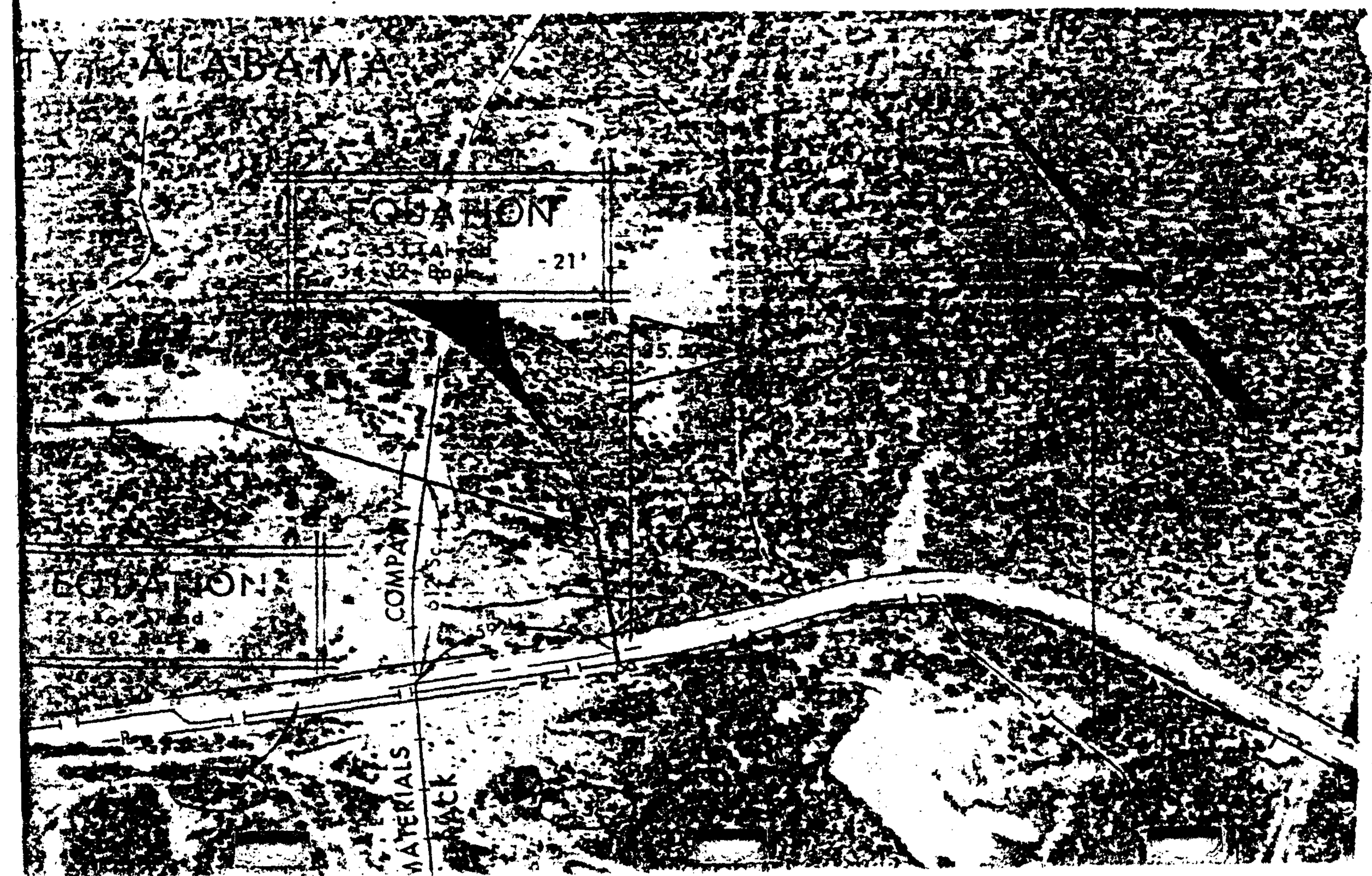

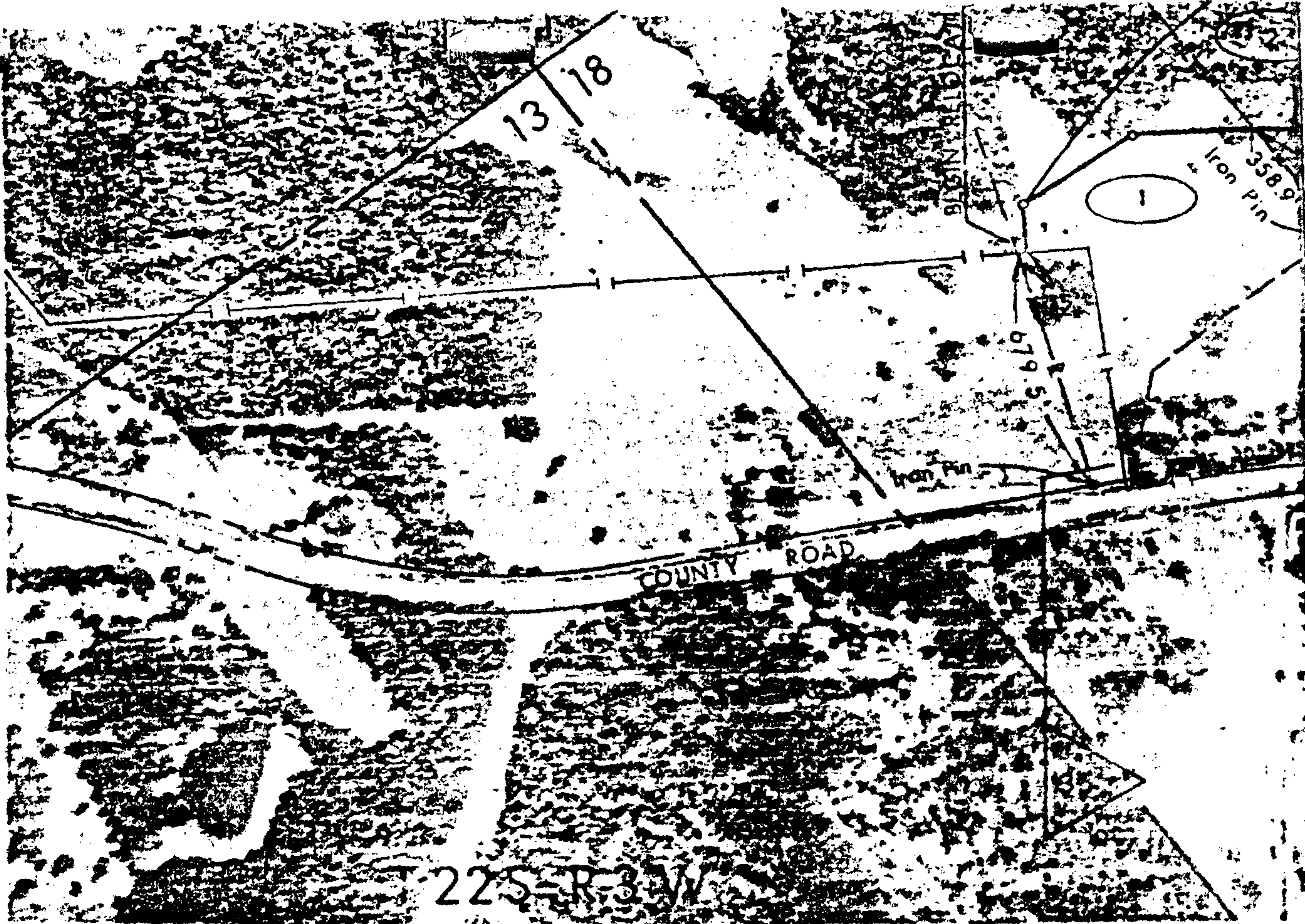
