FORECLOSURE DEED

Whereas, The First National Bank of Birmingham, a national banking association, (hereinafter sometimes called Bank) was, on December 15, 1980, the owner and holder of the following described mortgage and the debt secured thereby: mortgage executed by Pettis Construction Company, Inc., a corporation, (hereinafter called Mortgagor) to the Bank on October 26, 1978, which mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama in Book 384, page 852 (hereinafter called Mortgage); and
