

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS: That Ralph Scott McDanal and wife, Terri F. McDanal, did, on to-wit, May 9, 1980 execute a mortgage to Engel Mortgage Company, Inc., which mortgage is recorded in BOOK 402, Page 723, et seq., in the Office of the Judge of Probate of Shelby County, Alabama, and which said mortgage, security, lien and the indebtedness secured thereby, was assigned to and acquired by Engel Mortgage Company, Inc., in the Office of the Probate Judge of Shelby County, Alabama; and
