My name is John P. Carlton. I am a lawyer duly licensed by the State of Alabama to practice law. I have practiced law in Birmingham, Alabama, since 1962. My offices presently are located at 727 Frank Nelson Building, Birmingham.

I was well acquainted with Edna M. Alexander and her husband, Houston F. Alexander, during their respective lifetimes for more than 25 years. My knowledge of them grew out of the fact that we lived in the same neighborhood and attended church together at Central Park Baptist Church where the Alexanders were active during their lifetimes, I also being an active member of that congregation.

Edna M. Alexander died at Birmingham, Alabama, on April 23, 1977. Her husband, Houston F. Alexander, died at Birmingham, Alabama, on January 30, 1979. The Alexanders had only one child, Jewell A. Carter, who is an adult under no legal disability.

At the time of her death, the said Edna M. Alexander had an estate separate from that of her husband, and exclusive of hereditaments held by them jointly with right of survivorship consisting of the following parcels of land situated in Shelby County, Alabama:

McGaughy, situated in Sections 8 and 9, in Township 22, South, Range 3 West, Shelby County, Alabama, as recorded in the Office of the Probate Judge of Shelby County, Alabama, in Volume 3 of Maps, Page 30, said map referred to being signed and acknowledged by Mrs. McGaughy on the 9th day of April, 1938; situated in Shelby County, Alabama. Also ten acres, more or less, in the S 1/2 of the NW 1/4 of the SE 1/4 Section 8 in Township 22 South, Range 3 West, situated in Shelby County, Alabama.

Four and 35/100 acres off the South and on the East side of Montevallo and Dogwood public road as now located and being in the Northeast Fourth of the Southwest Fourth of Section 8, also the South Ten and one-half (10 1/2) acres saving and excepting five acres off the East end thereof, and being in the Northwest Fourth of the Southeast Fourth of said Section Eight, all in Township 22 South, Range 3 West. (The said public road is the first road which is on the West side of McHenry Creek in said 40 acre tract.) Same being Plots 13 and 5 1/2 acres of Plot 12 of the J. L. and Ida McGaughy Lands situated in Shelby County, Alabama.

The East 5 acres of the South 10 1/2 acres of the Northwest Fourth of the Southeast Fourth of Section Eight (8), Township 22 South, Range 3 West.

Tract No. 2, containing 10 acres, more or less, as shown by map showing division of lands owned by Mrs. Mary I. McGaughy, situated in Sections 8 and 9, in Township 22, South, Range 3 West, Shelby County, Alabama, as recorded in the Office of the Probate Judge of Shelby County, Alabama, in Volume 3 of Maps, page 30, said map referred to being signed and acknowledged by Mrs. McGaughy on the 9th day of April, 1938, situated in Shelby County, Alabama.

Upon the death of the said Edna M. Alexander, I was engaged by Houston F. Alexander to assist him with her estate. Edna M. and Houston F. Alexander executed a joint will on February 6, 1950, a copy of which is in my possession. This will leaves the entire estate of each of them to the other.

A law clerk in my office made a diligent and thorough search to locate the witnesses to the will, being one Herbert J. Ward and one E. W. Liles, but was unable to do so. Neither was he able to locate anyone who knew either of these purported witnesses. After due investigation, it was determined that Edna M. Alexander owned no other property in her own right, exclusive of joint tenancies with Houston F. Alexander with right of survivorship, and that she had no debts. It was elected to make no further effort to probate her estate.

As noted, Houston F. Alexander died on January 30, 1979. He died testate, his will leaving his entire estate to the said Jewell A. Carter. His will has been admitted to probate in Jefferson County, Alabama, in Case No. 97298 in the Probate Court of said county. The time for filing claims in said estate has expired, and no claims were filed.

Jewell A. Carter is the sole heir of Edna M. Alexander and Houston F. Alexander. The purpose of this affidavit is to establish title in the above-described real property in Jewell A. Carter.
