

## MORTGAGE EXTENSION AGREEMENT

KNOW ALL MEN BY THESE PRESENTS: that, whereas CENTRAL STATE BANK, CALERA, ALABAMA,
hereinafter referred to as Mortgagee, is now the owner of that certain mortgage heretofore executed by  Russell Carden and wife, Connie Carden
to Central State Bank, Calera, Alabama
which mortgage is recorded in the Probate Office of Shelby County, Alabama, in Volume 387 at Page(s) 295
of Deeds and Mortgages, and is also the owner of the indebtedness secured by said mortgage, the amount of the principal
indebtedness thereby secured being now $\frac{4,628.64}{1.628.64}$ : and,
WHEREAS, the undersigned Russell Carden and wife. Connie Carden
now the owner(s) are, subject to said debt and mortgage, of the property described in and conveyed by said
mortgage, and have requested the Mortgagee to grant an extension of time of payment of said mortgage indebtedness so as to make the same payable as hereinafter set forth, and the Mortgagee has agreed to grant such extension upon the terms and conditions hereinafter stated:
NOW, THEREFORE, in consideration of the premises and to evidence the agreement of the parties, the undersigned agree—to pay to the Mortgagee or to the successors or assigns of the Mortgagee, the said indebtedness in installments as follows:
Due and payable in 47 monthly payments of \$97.00 each and 1 final payment of
\$69.64, with the first of these being due and payable on March 5, 1981.
THIS IS AN EXTENSION OF TIME ONLY -MORTGAGE TAX PAID AS ABOVE.
The Mortgagee has granted the extension of the time of payment of said mortgage indebtedness upon the following conditions: (1) the property described in said mortgage is owned by the undersigned subject to the debt and mortgage hereinabove described; (2) no lien or encumbrance has been placed upon or attached to said property prior to the lien of the mortgage indebtedness hereinabove described; (3) this extension agreement shall have the effect of confirming unto the Mortgagee herein named (whether such Mortgagee be designated in the mortgage hereinabove described or has succeeded to the rights of the Mortgagee by the transfer and assignment of the Mortgage indebtedness) every right, privilege and benefit conferred upon the Mortgagee in said mortgage and (4) said mortgage shall be and continue a first lien on the property described herein; (5) said mortgage and all its covenants, terms and conditions shall remain in full force and effect except as besein modified; (6) this instrument shall be of no effect until approved by said Mortgagee; (7) the acceleration provisions in said mortgage remain unmodified by this agreement; (8) If the original maker of the above debt or any other person, in any way or at any time, obligated to pay said original debt signs this agreement, such signature shall be conclusive evidence that such person remains obligated to pay this debt as extended.
