WHEREAS, the undersigned W. Truman Barefield and wife, Evelyn Barefield
now the owner(s) are , subject to said debt and mortgage, of the property described in and conveyed by said mortgage, and requested the Mortgagee to grant an extension of time of payment of said mortgage
