## ITEM ONE

I direct that all of my just debts and funeral expenses together with the costs of administration of my estate be paid by my Executor as soon as practicable after my death.

## ITEM TWO

I give and bequeath to my beloved husband Lewis L. Little all the rest and residue of my estate, real, personal or mixed wheresoever located that I may own at my death, to have and to hold forever. ## ITEM THREE

I hereby nominate, constitute and appoint Lewis L. Little to be the Executor of this my Last Will and Testament, and waive the furnishing of bond by him in order to qualify as such Executor. In the event for any reason he should fail to qualify within a reasonable time after my death, I nominate and appoint my nephew Winston Hughes Morris to be the Executor and he shall also be exempt from furnishing any bond or security to qualify as such Executor.

I vest my Executor with full power and authority to sell, transfer and convey any of my property, either real or personal, which I may own at my death and upon such terms and conditions as he may determine and to do every
