TOGETHER WITH all buildings and improvements now or hereafter erected thereon and all screens, shades, storm sash and blinds, and heating, lighting, plumbing gas Sectric, ventilating, refrigerating and air-conditioning equipment used in connection therewith, all of which, for the purpose of this mortgage, shall be deem fixfures and subject to the lien hereof, and the hereditaments and appurtenances pertaining to the property above described, all of which is referred to hereinafter 'the "premises".

In event of loss Mortgagor will give immediate notice by mail to the Mortgagee who may make proof of loss if not made promptly Mortgagor, and each insurance company concerned is hereby authorized and directed to make payment for such loss directly to Mortgagee instead Mortgagor. (2) To pay all taxes and special assessments of any kind that have been or may be levied or assessed upon said premises, or any part thereof. (3) In i . Vevent of default by Mortgagor under Paragraphs 1 or 2 above, Mortgagee, at its option (whether electing to declare the whole indebtedness secured hereby due a collectible or not), may (a) effect the insurance above provided for and pay the reasonable premiums and charges therefor; (b) pay all said taxes and assessment without determining the validity thereof, and (c) pay such liens and all such disbursements, with interest thereon from the time of payment at the highest re allowed by law, and such disbursements shall be deemed a part of the indebtedness secured by this Mortgage and shall be immediately due and payable Mortgagor to Mortgagee. (4) To keep the buildings and other improvements now or hereafter erected in good condition and repair, not to commit or suffer a waste or any use of said premises contrary to restrictions of record or contrary to laws, ordinances or regulations of proper public authority, and to pen Mortgagee to enter at all reasonable times for the purpose of inspecting the premises, not to remove or demolish any building thereon; to complete within C Hundred Eighty (180) Days or restore promptly and in a good and workmanlike manner any building which may be constructed, damaged or destroyed thereon a to pay, when due, all claims for labor performed and material furnished therefor. s to the Purchaser at the atoresaid sale, imn after such sale, in the (2) Mortgagor agrees nder possession of the hereinabove described event such possession has not previously been surrendered by Mortgagor, and for failure to surrender possession, will pay to Furchaser the reasonable rental value of the premises during or after the redemption period. (3) In the event said premises are sold by Mortgagee, Mortgagor, if a signer on the note, shall be liable for any deficiency remaining after sale of the premises, and application of the proceeds of said sale to the indebtedness secured and to the expenses of conducting said sale, including attorney's fees and legal expenses as provided on the reverse side.
