FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, THAT:

WHEREAS, default was made in the payment of the indebtedness secured by the mortgage executed by Walter Kuehn,
Jr. and wife Lois M. Kuehn to Charter Mortgage Company,
recorded in Book 394, page 610, of the records in the Office
