My name is Robert White, and I am the Overseer of the Church of God in Alabama.

The purpose of this Affidavit is to induce Cahaba Title, Inc. and Safeco Title Insurance Company to furnish title insurance on the sale of the Moores Cross Roads property in Shelby County, Alabama, more particularly described as follows, to-wit:

Commence at the intersection of the north line of the Columbiana and Tuscaloosa Road with the west line of Montevallo and Ashville Road and run thence westerly along said Columbiana and Tuscaloosa Road a distance of 175 yards to the point of beginning; thence continue westerly along said right-of-way of Columbiana and Tuscaloosa Road a distance of 53 yards to fence stake; thence run North 50 yards to fence stake; thence run east 38 yards to fence stake; thence run southerly 50 yards, more or less to the point of beginning; being situated in Shelby County, Alabama, in the SE 1/4 of NW 1/4 of Section 2, Township 22 South, Range 3 West.

On November 29, 1980, I investigated the Church at Moores Cross Roads in Alabama and discontinued the Church because of inactivity, according to my responsibility. The form for discontinuing Churches is attached as Exhibit "A" and incorporated herein.

On February 2, 1981 I approved and authorized and directed the sale of the property in accordance with the by-laws of the Church of God as authorized by the Church of God General Assembly MINUTE. A copy of this action is attached as Exhibit "B" and incorporated herein.

On February 11, 1981 I notified the Ministry of the State that the Moores Cross Roads Church had been disbanded, and a purchaser had been found for the appraised value of \$45,000.00. A copy of this notice is attached as Exhibit "C"

and incorporated herein. There were only 5 no responses out of 625 Ministers so that the two-thirds majority vote as required by the Church of God General Assembly MINUTE was met. This procedure is the general procedure used for selling Church property valued over \$2,000.00 and has been used several times in this same manner.

The State Board of Trustees, with my consent, are now empowered to sell this property, in accordance with the by-laws of the Church of God as authorized by the Church of God General Assembly MINUTE. The State Board of Trustees, as certified by the State Secretary and Treasurer, are Claude Moore, W. M. Dollars and Melvin Massey. A copy of the Certification is attached as Exhibit "D" and incorporated herein.
