William Kirkwood (The "GRANTORS"), do hereby grant unto the said GRANTEES, a 20 foot wide easement of ingress and egress across a portion of the SW 1/4 of the SE 1/4 of Section 28, Township 19 South, Range 1 West, Shelby County, Alabama, and being more particularly described as follows:

Commence at the SW corner of the SE 1/4 of the SE 1/4 of Section 28, Township 19 South, Range 1 West, Shelby County, Alabama:  
Thence run East along the South line of said 1/4-1/4 Section a distance of 132.15 feet.  
Thence turn left 90° 12' for a distance of 15 feet to the point of beginning.  
Thence run West and parallel with the South line of said 1/4-1/4 Section a distance of 132 feet, more or less, to the West line of said 1/4-1/4 Section.

For the consideration aforesaid, the GRANTORS do grant unto said GRANTEES the right and privilege of perpetual use of said easement for such access purposes, together with all rights and privileges necessary or convenient for the full use and enjoyment thereof, including the right to cut and keep clear all trees, undergrowth and other obstructions on said easement when deemed reasonably necessary for the avoidance of danger in and about the use of said easement.

TO HAVE AND TO HOLD unto the said GRANTEES, their heirs and assigns, forever.
