## EASEMENT

New Jersey corporation, for and in consideration of the vacation by the TOWN OF HELENA, ALABAMA, a municipal corporation, of that certain road known as Project 71-1 from its point of intersection with the easement granted herein to its point of intersection with State Highway 261, and for other good and valuable consideration, hereby grants, warrants and conveys to the Town of Helena, Alabama, an easement and right-of-way for the construction, maintenance and repair of a public road. The foregoing easement is given on and across the land owned by Vulcan Materials Company in Shelby County, Alabama, more particularly described as follows:

Commence at the Southwest corner of the S. W. 1 of S. E. %, Section 10, Township 20 South, Range 3 West, being the point of beginning of the parcel of land herein .described; thence run in an easterly direction along the South boundary of said section for a distance of 834 feet, more or less, to the point of intersection with the west Right-of-Way line of Helena Street Project 71-1; thence run in a northerly direction along said west Right-of-Way for a distance of 50 feet to a point; thence run in a westerly direction along a line, being 50.00 feet from and parallel to said section line, for a distance of 830 feet, more or less, to the point of intersection with the west line of aforementioned quarter quarter section; thence proceed in a southerly direction along said west line of said quarter quarter section for a distance of 50 feet to the point of beginning.

Said property is lying in the S. W. % of S. E. %, Section 10, Township 20-S, Range 3 West, and contains 0.96 acre.

TO HAVE AND TO HOLD said easement and right-of-way to the Town of Helena, Alabama, its successors and assigns, forever.

Vulcan Materials Company hereby covenants that it is the owner in fee simple of, and is lawfully seized and possessed of, the above-described property and that it has a lawful right to convey the within-described easement and right-of-way.

Vulcan Materials Company reserves the right, at its own expense, to place pipelines, wires and roads over, under or through the easement
