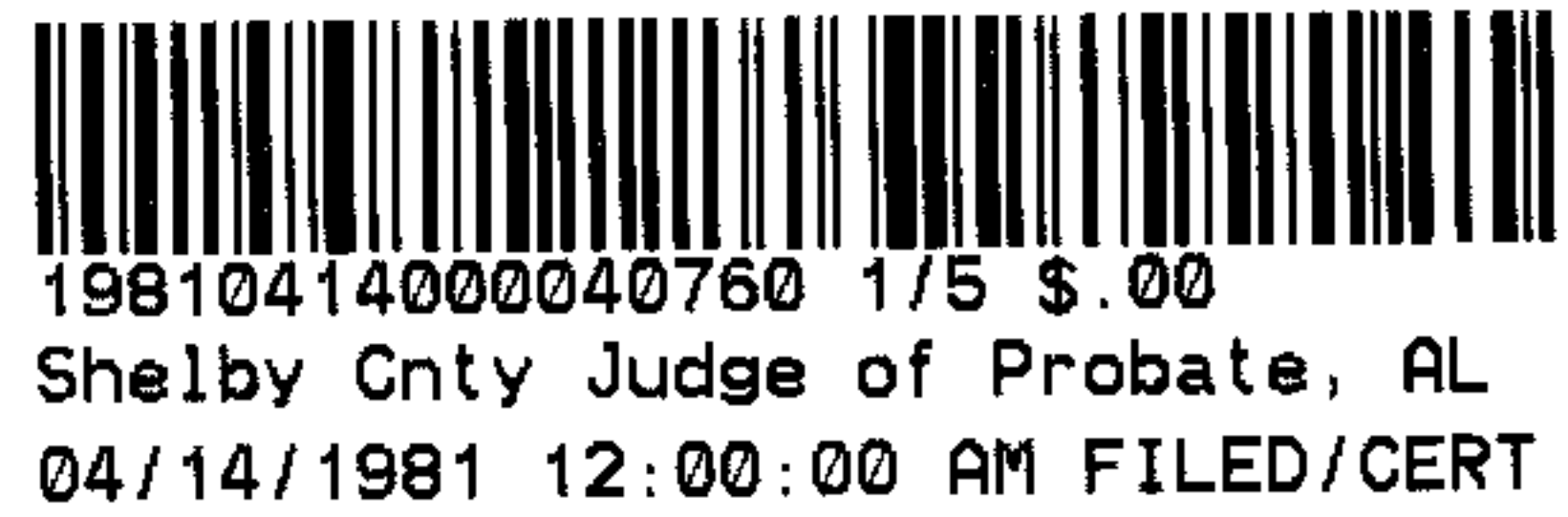

KNOW ALL MEN BY THESE PRESENTS: That I, Jeff Lewis Pilgreen, of the County of Chilton and the State of Alabama, being over the age of twenty-one years and of sound mind and disposing memory, do hereby make, publish and declare this to be my last Will and Testament, hereby revoking all wills and codicils at any time heretofore made by me.

FIRST:

I will and direct that all my just debts and funeral expenses be paid by my Executrix as soon after my death as practicable.

SECOND:

I give and devise all my real estate owned by me at the time of my death, including all buildings thereon, and all rights and easements appurtenant thereto, to my wife, Rosa S. Pilgreen, to have and to hold absolutely.

THIRD:

I will and devise all tangible and intangible personal property of every nature and wheresoever situated, owned by me at the time of my death, I give and bequeath unto my wife, Rosa S. Pilgreen, to have and to hold absolutely.

FOURTH:

That in event that my wife, Rosa S. Pilgreen, should predecease me, then I will and bequeath unto my children, to share and share alike all my real estate owned by me at the time of my death, including all buildings thereon and all rights and easements appurtenant thereto, to have and to hold absolutely, and to share and share alike.

FIFTH:

That in event that my wife, Rosa S. Pilgreen, should predecease me, then I will and devise all tangible and intangible personal property of every nature and wheresoever situated, owned by me at the time of my death, I give and bequeath unto my children, to share and share alike, and to have and to hold absolutely.

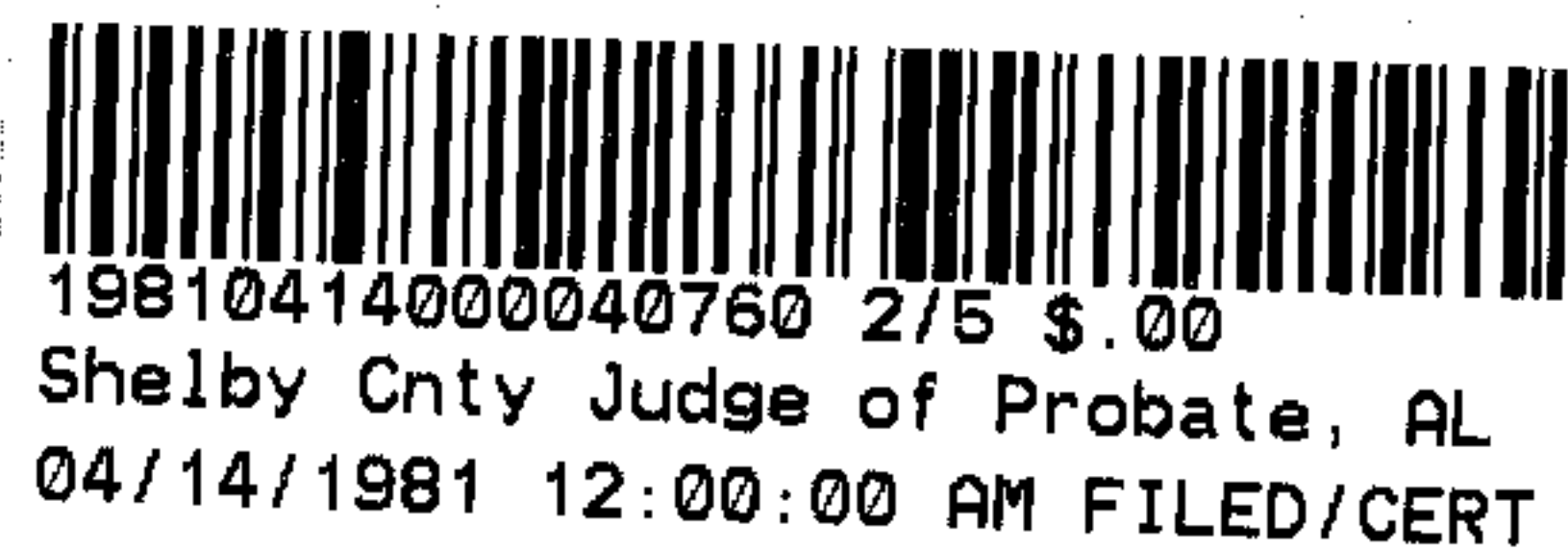

SIXTH:

I appoint my wife, Rosa S. 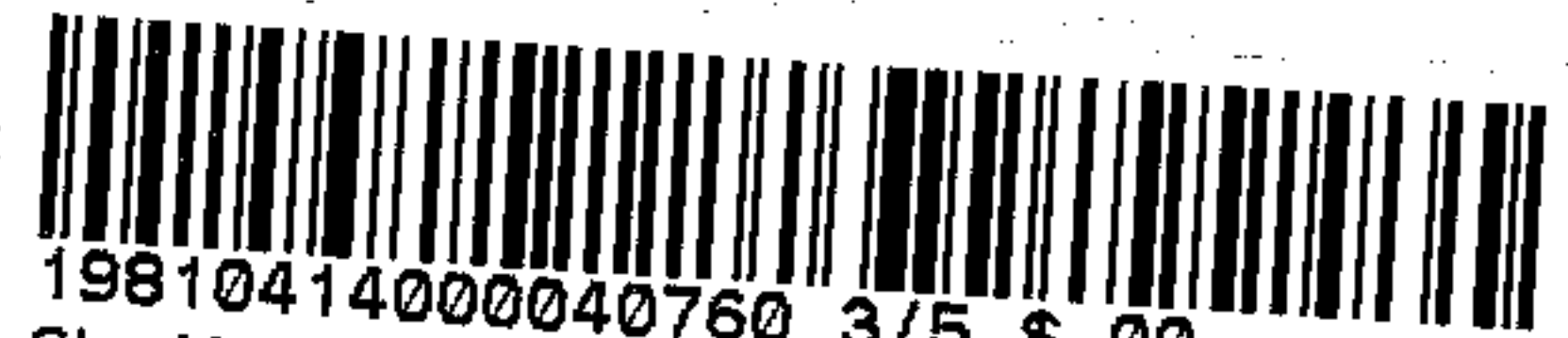
