AFFIDAVIT OF ROBERT E. POWERS

Before me, Barbara J. Chayin, a notary public in and for Jefferson County, Alabama, personally appeared Robert E. Powers, who is known to me and who did upon oath depose and say:

My name is Robert E. Powers. I reside at 5537 Park View Circle, Birmingham, Shelby County, Alabama, 35243. I am 75 years of age.

On April 26, 1945, I was living next door to the Butler family homeplace. They owned approximately 45 acres of property on U. S. Highway 31 near Pelham, Alabama. My address then was Route 1, Helena, Alabama. I had known the Butlers and been their next-door neighbor since 1918. I lived at that location and was their closest neighbor until 1980. I knew very well Joseph H. Butler and his sister, Alice E. Butler. I also knew John P. Lee, who in 1945 was a Justice of the Peace in Shelby County, Alabama, but not a lawyer, and not learned in the law. On April 26, 1945, Joseph H. Butler asked me to come to the Butler house to witness a deed which had been prepared by Mr. Lee and by which Joseph H. Butler told me he planned to convey to his sister,

Alice, all of the interest which he had in the Butler property, including not only what he had gotten by deed from his parents but what he received by inheritance from his brother and from his parents. At that time, Joseph H. Butler and Alice E. Butler were both living in the Butler house.

I witnessed the signature of Joseph H. Butler on that deed. A copy of the deed is attached to this affidavit. My signature appears on the deed as a witness. There is no doubt in my mind but that Joseph H. Butler was of sound mind and knew exactly what he intended to do on April 26, 1945. He expressed the intention to give everything to Miss Alice. He told both me and Mr. Lee that he was giving everything to Miss Alice, who is his only living sister, who was then unmarried, and who is still living and unmarried. Miss Alice continued to live in the Butler place until very recently.

The Butlers owned no property in the N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 13. Instead, they owned land in the N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 13. The attached deed contains more than one error as to what Joseph H. Butler intended to convey.

From 1945 to the present time, it has been common knowledge in the neighborhood that Joseph H. Butler conveyed everything which he owned in 1945 to Miss Alice. I have never heard anybody, either in the Butler family, or not in the family, assert anything to the contrary until very recently when a rumor started that there was a mistake in the deed.






