by these presents do es hereby grant, bargain, sell and convey unto the said Alabama Power

COMPANY, (hereinafter called the Company), its successors and assigns, the following described
real estate, situated in the County of Shelby and State of Alabama, and described as follows:

All that part of the East Half of the Southeast Quarter of Section 29, Township 20
South, Range 2 East, that lies west of Yellow Leaf Creek, Shelby County, Alabama.
Less and except mineral rights and subject to an oil lease recorded in Book 326,
Page 363, in the Probate Office of Shelby County, Alabama, rights to which are re-
tained by Grantor.

And the grantor covenants with the said Company, its successors and assigns, that she is lawfully seized in fee of the aforegranted premises; that the said premises contain the number of acres hereinabove mentioned; that they are free from all encumbrance; that she has a good right to sell and convey the same to the said Company, its successors and assigns, and that she will warrant and defend the said premises to the said Company, its successors and assigns, forever, against the lawful claims and demands of all persons.
