Wooley hereinafter called Assignors, to secure the repayment of a loan to Assignors from STATE BANK OF THE GULF, hereinafter called Assignee, as set out below, do hereby sell, assign, transfer and convey (subject to the matters hereinafter set out) that certain Mortgage dated April 7, 1981 in the amount of \$120,000.00 made by Neil P. Damron and wife, Kathryn E. Damron, to the Assignors.

This assignment is given to secure the repayment of a loan from Assignee to Assignors as evidenced by a Loan of even date herewith in the amount of \$58,000.00.

Assignors and Assignee agree that all payments due Assignors under said Loan secured by mortgage, including principal and interest, shall be paid to STATE BANK OF THE GULF, GULF SHORES, ALABAMA, to be used first to reduce the interest due on the note from Assignors to STATE BANK OF THE GULF, at the rate of 17.50% per annum, and the balance to be applied against the principal due thereon.

In the event of default by T. C. Wooley and Fairley C. Wooley on said note, Assignee is hereby authorized to foreclose on mortgage assigned herein and apply the proceeds of any sale first to the Assignee's expenses of foreclosure (including a reasonable attorney's fee), secondly to the unpaid balance (including interest) due on the said Loan from Assignors to Assignee, and the balance to the Assignors.
