And for the purpose of further securing the payment of said indebtedness the Mortgagors warrant, covenant and agr with Mortgagee, its successors and assigns, as follows:

- 1. That they are lawfully seized in fee and possessed of said mortgaged property and have a good right to convey the same aforesaid, that they will warrant and forever defend the title against the lawful claims of all persons whomsoever, and that said proper is free and clear of all encumbrances, easements and restrictions not herein specifically mentioned.
- 2. That they will pay all taxes, assessments, or other liens taking priority over this mortgage when imposed legally upon sa mortgaged property, and should default be made in the payment of same, or any part thereof, said Mortgagee may pay the same (t Mortgagee is not obligated to do so).
- 3. That they will keep the buildings on said premises continuously insured in such amounts, in such manner and with su companies as may be satisfactory to the Mortgagee against loss by fire (including so-called extended coverage), wind, and such oth hazards as Mortgagee may specify, with loss, if any, payable to said Mortgagee, and will deposit with Mortgagee policies of such insuran or, at Mortgagee's election, certificates thereof, and will pay premiums therefor as the same become due. Mortgagors shall give immedia notice in writing to Mortgagee of any loss or damages to said premises caused by any casualty. If Mortgagors fail to keep said proper insured as above specified, the Mortgagee may insure said property (but Mortgagee is not obligated to do so) for its insurable val against loss by fire, wind, and other hazards for the benefit of Mortgagors and Mortgagee, or Mortgagee alone, at Mortgagee's electic The proceeds of such insurance shall be paid by insurer to Mortgagee, which is hereby granted full power to settle and compromi eclaims under all policies and to demand, receive and receipt for all sums becoming due thereunder; said proceeds, if collected, to credited on the indebtedness secured by this mortgage, less cost of collection same, or to be used in repairing or reconstructing the premise as the Mortgagee may elect.
 - 4. That all amounts so expended by the Mortgagee for insurance or for the payment of taxes or assessments or to dischar prior liens shall become a debt due the Mortgagee, shall be at once payable without demand upon or notice to any person, shall be interest at the rate of interest payable on the principal sum of the note described above or, if no such rate of interest is specific or if the rate specified would be unlawful, at the rate of 8% per annum from date of payment by Mortgagee, and such debt and the interest thereon shall be secured by the lien of this mortgage; and upon failure of Mortgagors to reimburse Mortgagee for all amounts so expende at the election of the Mortgagee and with or without notice to any person, Mortgagee may declare the entire indebtedness secured by the mortgage due and payable and this mortgage subject to foreclosure and the same may be foreclosed as hereinafter provided.
 - 5. To take good care of the mortgaged property described above and not to commit or permit any waste thereon, and to ke the same repaired and at all times to maintain the same in as good condition as it now is, reasonable wear and tear alone excepted.
 - 6. That no delay or failure of the Mortgagee to exercise any option to declare the maturity of any debt secured by this mortga shall be taken or deemed as a waiver of the right to exercise such option or to declare such foreseiture either as to past or present desau on the part of said Mortgagors, and that the procurement of insurance or payment of taxes or other liens or assessments by the Mortgag shall not be taken or deemed as a waiver of the right to declare the maturity of the indebtedness hereby secured by reason of the failu of the Mortgagors to procure such insurance or to pay such taxes, liens, or assessments, it being agreed that no terms or conditions contain in this mortgage can be waived, altered, or changed except as evidenced in writing signed by the Mortgagors and by the Mortgages.
 - 7. That they will well and truly pay and discharge every indebtedness hereby secured as it shall become due and payable includi the note or notes above described, any renewals or extensions thereof, and any other notes or obligations of Mortgagors to Mortgag whether now or hereaster incurred.

UPON CONDITION, HOWEVER, that if the Mortgagors shall well and truly pay and discharge all the indebtedness hereby secured (including future advances) as the same shall become due and payable and shall in all things do and perform all acts and agreement by them herein agreed to be done according to the tenor and effect hereof, then and in that event only this conveyance shall be and become null and void; but should default be made in the payment of any indebtedness hereby secured or any renewals or extensions thereof or any part thereof or should any interest thereon remain unpaid at maturity, or should default be made in the repayment of any sum expended by said Mortgagee under the authority of any of the provisions of this mortgage or should the interest of said Mortgagee in said property become endangered by reason of the enforcement of any lien or encumbrance thereon so as to endanger the debt hereby secured, or should a petition to condemn any part of the mortgaged property be filed by any authority having power of eminent domain, by them herein agreed to be done according to the tenor and effect hereof, then and in that event only this conveyance shall be and become null and void; but should default be made in the payment of any indebtedness hereby secured or any renewals or extensions thereof or any part thereof or should any interest thereon remain unpaid at maturity, or should default be made in the repayment of any sum expended by said Mortgagee under the authority of any of the provisions of this mortgage or should the interest of said Mortgagee in said property become endangered by reason of the enforcement of any lien or encumbrance thereon so as to endanger the debt(s) hereby secured, or should a petition to condemn any part of the mortgaged property be filed by any authority having power of eminent domain, or should any law, either federal or state, be passed imposing or authorizing the imposition of a specific tax upon this mortgage or the debt(s) hereby secured or permitting or authorizing the deduction of any such tax from 1 the principal or interest secured by this mortgage or by virtue of which any tax or assessment upon the mortgaged premises 17 shall be charged against the owner of this mortgage or should at any time any of the stipulations contained in this mortgage be declared invalid or inoperative by any court of competent jurisdiction or should the Mortgagors fail to do and perform any other act or thing herein required or agreed to be done, then in any of said events the whole of the indebtedness hereby secured, or any portion or part of same which may not at said date have been paid, with interest thereon, shall at once become due and payable and this mortgage subject to foreclosure at the option of the Mortgagee, notice of the exercise of such option being hereby expressly waived; and the Mortgagee shall have the right to enter upon and take possession of the property hereby conveyed and after or without taking such possession to sell the same before the Court House door of the County (or the division thereof) where said property, or a substantial part of said property, is located, at public outcry for cash, after first giving notice of the time, place and terms of such sale by publication once a week for three consecutive weeks prior to said sale in some newspaper published in said County, and upon the payment of the purchase money the Mortgagee or auctioneer is authorized to execute to the purchaser for and in the name of the Mortgagors a good and sufficient deed to the property sold. The Mortgagee shall apply the proceeds of said sale: First, to the expense of advertising, selling and conveying, including a reasonable attorney's fee not exceeding 15 percent of the unpaid debt after default if the original amount financed exceeded \$300; second, to the payment of any amounts that may have been expended or that may then be necessary to expend in paying insurance, taxes and other encumbrances, with interest thereon; third, to the payment in full of the indebtedness hereby secured and interest thereon, whether the same shall or shall not have fully matured at the date of said sale, but no interest shall be collected beyond the date of sale; and fourth, the balance, if any, to be paid over to the said Mortgagors or to whomsoever then appears of record to be the owner of Mortgagors' interest in said property.
