KNOW ALL MEN BY THESE PRESENTS, That the undersigned

Douglas M. Kent and wife Nina W. Kent

for and in consideration of the sum of

Dollars 10.00 ) to us in hand paid by

Alabama Power Company, a corporation, the receipt whereof is hereby acknowledged, we hereby grant to said Alabama Power Company, its successors and assigns, the right to cut and trim and to keep cut and trimmed, and remove all timber or other woody growth, including overhanging limbs, within fifteen (15) feet of the strip of right of way described hereinafter on which electric transmission lines of said Alabama Power Company, its successors and assigns, are to be constructed adjacent to grantor(s) land in the East Half of the Northwest Quarter (E $\frac{1}{2}$  of NW $\frac{1}{4}$ ) of Section 14, Township 21 South, Range 3 West, Shelby County, Alabama.

Said strip of right of way being more particularly described as follows: To reach the point of beginning of said strip of right of way, commence at the Northwest corner of Section 13, Township 21 South, Range 3 West; thence run East along the North boundary line of said Section 13 a distance of 66.5 feet to a point; thence turn an angle to the right of 151 degrees 54 minutes and run South 64 degrees 04 minutes West a distance of 148.5 feet to a point; thence turn an angle to the left of 08 degrees 33 minutes and run South 55 degrees 31 minutes West a distance of 1219.3 feet to a point; thence turn an angle to the left of 01 degree 11 minutes and run South 54 degrees 20 minutes West a distance of 369.9 feet to a point; thence turn an angle to the left of 05 degrees 16 minutes and run South 49 degrees 04 minutes West a distance of 342.2 feet to a point; thence turn an angle to the left of 20 degrees 15 minutes and run South 28 degrees 49 minutes West a distance of 294.7 feet to a point; thence turn an angle to the right of 38 degrees 37 minutes and run South 67 degrees 26 minutes West a distance of 308.3 feet to a point; thence turn an angle to the right of 34 degrees 12 minutes and run North 78 degrees 22 minutes West a distance of 344.7 feet to a point; thence turn an angle to the right of 24 degrees 25 minutes and run North 53 degrees 57 minutes West a distance of 275.4 feet to a point; thence turn an angle to the left of 24 degrees 50 minutes and run North 78 degrees 47 minutes West a distance of 110 feet, more or less, to a point, such point being the point of beginning of the strip of right of way herein described; therefrom, said strip of right of way is ten (10) feet in width and lies five (5) feet on each side of a center line and the continuations thereof which begins at such point of beginning and runs North 78 degrees 47 minutes West a distance of 87.1 feet to a point; thence turn an angle to the left of 03 degrees 12 minutes and run North 81 degrees 59 minutes West a distance of 687 feet, more or less, to a point, such point being the point of ending of said strip of right of way.

Also, the right to install and maintain anchors and guy wires on lands adjacent to the above described strip of right of way. we TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
