



Commence at the Northwest corner of Section 10, Township 24 North, Range 15 East, thence run East along the North line of said Section 10, a distance of 3115.04 feet; thence turn an angle of 89 deg. 29 min. 20 sec. to the right and run a distance of 312.34 feet to the point of beginning; thence turn an angle of 76 deg. 56 min. 46 sec. to the left and run a distance of 169.85 feet; thence turn an angle of 97 deg. 15 min. 13 sec. to the right and run a distance of 246.30 feet; thence turn an angle of 103 deg. 15 min. 24 sec. to the right and run a distance of 159.71 feet; thence turn an angle of 52 deg. 08 min. 23 sec. to the right and run a distance of 59.81 feet; thence turn an angle of 16 deg. 09 min. 18 sec. to the right and run a distance of 117.38 feet; thence turn an angle of 86 deg. 11 min. 42 sec. to the right and run a distance of 10.39 feet to the point of beginning. Situated in the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , Sec. 10, Township 24 North, Range 15 East, and containing 0.81 acres.
