This form of mortgage combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property. This mortgage shall be governed by the law of the jurisdiction in which the Proper is located. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law. SUC conflict fiell not affect other provisions of this Mortgage or the Note which can be given effect with the conflicting provision, and to this and the provisions of the Mortgage and the hote are declared to be warmenable.
- 16. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and and while Mortgage it the ti of execution or after recordation hereof.
- t 17. Transfer of the Property: Assumption. If all or any part of the Property or an interest therein is sold or transferred by Borrower without Lender's prior written consent, excluding (a) the creation of a light or encumbrance subordinate to this Mortgage, (b) the creation of a purchase money security interest for household appliances. (c) a transfer by devise, descent or by operation of law upon the death of a joint tenant or (d) the gran of any leasehold interest of three years or less not containing an option to purchase, Lender may, at Lender's option declare all the sums secured by this Mortgage to be immediately due and payable. Lender shall have waived swin option accelerate if, prior to the sale or transfer, Lender and the person to whom the Property is to be sold or transferred reach agreement in writing that the credit of such person is satisfactory to Lender and that the interest payable on sums secured by this Mortgage shall be at such rate as Lender shall request. If Lender has waived the option to accelerate provided in this naragraph 17, and if Borrower's successor in interest has executed a written assumption agreement accepted in writing by Lender. Lender shall release Borrower from all obligations under this Mortgage and 1 Note.

If Lender exercises such option to accelerate, Lender shall mail Borrower notice of acceleration in accordance paragraph 14 hereof. Such notice shall provide a period of not less than 30 days from the date the notice is mailed within which Borrower may pay the sums declared due. If Borrower fails to pay such sums prior to the expiration of st period, Lender may, without further notice or demand on Borrower, invoke any remedies permitted by paragraph 18 here

NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

18. Acceleration; Remedies. Except as provided in paragraph 17 hereof, upon Borrower's breack of any covenant or agreement of Borrower in this Mortgage, including the covenants to pay when du any sums secured by this Mortgage, Lender prior to acceleration shall mail notice to Borrower as provided in paragraph 14 hereof specifying: (1) the breach: (2) the action required to cure such breach: (3) a date, not less than 30 days from the date the notice is mailed to Berrower, by which such breach must be cured; and (4) that failure to cure such breach on or before the data specifi in the notice may result in acceleration of the sums secured by this Mortgage and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration the right to bring a court action to assert the non-existence of a default or any ether defense of Borrower to acceleration and sale. If the breach is not cured on or before the date specified in the notice, Lender at Lender's option may delcare all of the sums secured by this Mostgage to be immediately due and payable without further demand and may invoke the power of sals and any othe remedias permitted by applicable law. Lender shall be entitled to collect all reasonable costs a expenses incurred in pursuing the remedies provided in this paragraph 18, including, but not limited to, reasonable attorney's fees.

If Lender invokes the power of sale, Lender shall mail a copy of a notice of sale to Serrower the manner provided in paragraph 14 hereof. Lender shall publish the notice of sale once a seek three consecutive weeks in some newspaper published in Shelby County, Alabama, and thereupon shall sell the Property to the highest bidder at public auction at the front door of t County Courthouse of said County. Lender shall deliver to the purchaser Lender's dand conveying Property so sold. Lender or Lender's designee may purchase the Property at any sale. Sorrower covenants and agrees that the proceeds of the sale shall be applied in the following order: (a) all reasonable costs and expenses of the sale, including, but not limited to, reasonable attorne fees and costs of title evidence; (b) to all sums secured by this Mortgage; and (c) the excess, i any, to the person or persons legally entitled thereto.

19. Borrower's Right to Reinstate. Notwithstanding Lender's acceleration of the sums secured by this Mortgage. Borrower shall have the right to have any proceedings begun by Lender to enforce this Hortgage discontinue any time prior to the earlier to occur of (1) the fifth day before sale of the Property pursuant to the power of sal contained in this Mortgage or (ii) entry of a judgment enforcing this Mortgage if: (a) Borrower pays Lender all sums which would be then due under this Mortgage, the Note and notes securing Future Advances. If any, had no acceleration occurred; (b) Borrower cures all breaches of any other covenants or agreements of Borrower contained in this Mortgag (c) Borrower pays all reasonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage and in enforcing Lender's remedies as provided in paragraph is hereof, including, but not limited to, reasonable attorney's fees; and (d) Borrower takes such action as Lender may reasonably require to assur that the lien of this Mortgage, Lender's interest in the Property and Borrower's obligation to pay the sums secured this Mortgage shall continue unimpaired, Upon such payment and cure by Borrower, this Mortgage and the continue secured thereby shall remain in full force and effect as if no acceleration had occurred.

Assignment of Rents: Appointment of Receiver; Lender in Possession. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 18 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 18 hereof or abandonment of the Property, Lender, in person, by agent or by judicially appointed receiver, shall be entitled to enter upon, take possession of and manage the Property and to collect the rents of the Property including those past due. All rents collected by Lender or the receiver shall be applied first to payment of the costs of management of the Porperty and collection of rents, including, but not limited to, receiver's fees, premiums on receiver's bonds and reasonable attorney's fees, and then to the sums secured by this mortgage. Lender and the receiver shall be liable to account for only those rents actually received.

21. Future Advances. Upon request of Borrower, Lender, at Lender's option prior to release of this Mortgage, may make Future Advances to Borrower. Such Future Advances, with interest thereon, shall be secured by this Mortgage when evidenced by promissory notes stating that said notes are secured hereby.

22. Release. Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void, and Lender shall release this Mortgage, without charge to Borrower. Borrower shall pay all costs of recordation, if any.

23. Walver of Homestead, Dower and Curtesy. Borrower hereby waives all rights of homestead exemption in the Property and relinquishes all right of dower and curtesy in the Property.
