WHEREAS, the title of Alabama Power Company to the property hereinafter described is subject to the lien of the Indenture dated as of January 1, 1942, as amended and supplemented (hereinafter called the Indenture), executed by Alabama Power Company (hereinafter called the Company) to Chemical Bank & Trust Company, as Trustee; and

WHEREAS, the name of Chemical Bank & Trust Company was changed to Chemical Bank New York Trust Company and said Chemical Bank New York Trust Company thereafter merged into Chemical Bank and said Chemical Bank is now successor Trustee under the Indenture; and

WHEREAS, pursuant to the provisions of the first paragraph of Section 10.04 of the Indenture, the Company has requested the undersigned, as Trustee under the Indenture, to release such property from the lien of the Indenture and such other action has been taken in respect thereto as is required by the Indenture.

NOW, THEREFORE, Chemical Bank, as successor Trustee, under authority of the first paragraph of Section 10.04 of the Indenture, does hereby release and quitclaim from the lien of the Indenture (subject to the exceptions and reservations set forth in the hereinafter described deed, if any), all of its right, title and interest in and to the following described property located in Shelby County, Alabama, more particularly described as follows:

Parcel I

Commence at the NW corner, Section 36, Township 24 North, Range 15 East and proceed south along the west line of said quarter section, which is the grantor's west property line, a distance of 455 feet, more or less, to the point of beginning and the 397 contour (MSL); thence proceed south along said quarter section a distance of 800 feet, more or less to the 397 contour (MSL); thence follow the meanderings of the 397 contour (MSL) in a easterly, northerly and westerly direction, a distance of 1480 feet, more or less, to the point of beginning. Also commence at the NW corner of NW $\frac{1}{4}$, Section 36, Township 24 North, Range 15 East, Shelby County, Alabama and proceed south along the west line of said quarter section, which is the grantor's west property line, a distance of 1385 feet, more or less, to the point of beginning and the 397 contour (MSL); thence proceed south along said quarter section, a distance of 50 feet, more or less, to the 397 contour (MSL); then follow the meanderings of the 397 contour (MSL); in an easterly, northerly and westerly direction, a distance of 65 feet, more or less to the point of beginning.

Parcel II

Commence at the NE corner of NW $\frac{1}{4}$ of SE $\frac{1}{4}$, which is the point of beginning, and proceed west along the north line of said quarter-quarter section, which is the grantor's north property line, a distance of 345 feet, more or less, to the 397 contour (MSL); thence follow the meanderings of the 397 contour (MSL) in a southerly, easterly and northerly direction, a distance of 710 feet, more or less, to the north line of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 1, Township 24 North, Range 15 East; thence proceed west along the north line of said quarter-quarter section, which is the grantor's north property line, a distance of 309 feet, more or less, to the point of beginning.

Parcel III

Commence at the NW corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 36, Township 24 North, Range 15 East and proceed east along the north line of said quarter-quarter section, which is the grantor's north property line, a distance of 1305 feet more or less, to the point of beginning and the 397 contour (MSL); thence proceed east along the north line of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ and NE $\frac{1}{4}$ of NW $\frac{1}{4}$, a distance of 95 feet, more or less, to the 397 contour (MSL); thence follow the meanderings of the 397 contour (MSL) in a southerly, westerly and northerly direction a distance of 125 feet, more or less, to the point of beginning.
